## **Organizational Setting**

**ORGANIZATIONAL UNIT:** 

The Integrated Food Security Phase Classification (IPC) is a global, multi-partner innovative initiative to facilitate decision-making with improved food security analysis. The IPC is set of tools and protocols for classifying the severity and nature of food insecurity that integrates food security, nutrition and livelihood information into a clear statement about the nature and severity of food insecurity and implications for response. IPC incorporates a meta-analysis approach drawing on evidence-based analysis that includes a broad range of data sets and stakeholders.

The demand for IPC is continuing to increase and currently IPC activities are ongoing in more than 25 countries around the world. This global initiative is governed and strategically guided by an IPC Global Steering Committee, consisting of eleven major UN agencies, international NGOs and Regional Inter-governmental body agencies, including Action Contre la Faim (ACF) CARE International, CILSS, the Joint Research Centre of the European Commission, FAO, FEWSNET, Global Food Security Cluster, Oxfam GB, Save the Children (UK&US), SICA/PRESANCA and WFP.

### The IPC works:

- 1) At the global level, through the IPC Global Steering Committee (responsible for the strategic vision and oversight of IPC global standards worldwide), the IPC Technical Advisory Committee (TAG) (responsible for IPC technical normative developments) and the IPC Global Support Unit (GSU), (responsible for the coordination of IPC normative developments, IPC global standards on quality and compliance, and the global coordination of capacity building support to IPC activities worldwide):
- At the regional level, through GSU Certified Training Units (provides IPC Certified Training and Technical Assistance to countries in the region) and through Regional IPC Steering/Technical Working Groups that are integrated within existing regional platforms (responsible for regional overviews of IPC Country Analysis and the provision of partner support to IPC in countries in region): and
- At country level, inter-ministerial and multi-agency working groups support the introduction and implementation of the IPC by Country IPC Technical Working Groups linked and institutionalized within existing government and partner food security and nutrition platforms.

# **Reporting Lines**

The Food Security Officer (IPC) will be under the overall guidance of the IPC Global Programme Manager and where applicable, under the direct supervision of the FAO Regional Office and/or the Regional Inter-governmental agency (e.g. ASEAN, CILSS, IGAD, SADC, SARC, SICA).

### **Technical Focus**

Development and consolidation of the IPC in selected countries, contributing directly to Strategic Objective 1 Output 10301 (Improving capacities of governments and stakeholders to monitor trends and analyze the contribution of sectors and stakeholders to food security and nutrition) and Strategic Objective 5 Output 50202 (Improving capacities to undertake vulnerability and/or resilience analysis).

### **Key Results**

The GSU is seeking to recruit IPC Technical Food Security Officers to coordinate, manage and implement selected major deliverables of the of the IPC Global Strategic Programme (2014-2018), to be based at duty stations in Bangkok, Dakar, Johannesburg, Nairobi, and Rome. Selected areas of work at the global, regional and country level would include

- Strengthening the institutionalization, governance, technical consensus process of IPC,
- 2) Professionalized IPC training and technical capacity building assistance,
- Technical normative development of IPC protocols and IPC Quality and Compliance Reviews, and 3)
- Strategic and technical outreach for improved access and use of IPC in Decision Making.

### **Key Functions**

- Coordinate the implementation of technical support IPC Trainings and Meta-analysis events for Countries in the Region
- Manage a regional team and network of Certified IPC Trainers and act as GSU IPC Lead Trainer to Countries in the
  region, coordinating technical support and providing IPC Level 1, Level 2, Tailored Trainings and technical assistance
  to Countries, as needed
- Coordinate the Regional IPC Certification Campaign, in collaboration and with support of the IPC Regional Technical Working Group and the Regional Inter-governmental office
- Act as a Secretariat and Technical Lead of the IPC Regional Technical Working Group and support the Chair in a number of tasks including: to organize meetings; to implement and monitor the IPC Regional Strategy and Work Plans:
- Promote and facilitate a multi-agency ownership of the IPC at the regional and country level and among the different partner agencies through regular communication, information sharing and by encouraging joint planning and collaboration.
- Develop and finalise IPC tools, manual, guidance notes and training materials
- Provide technical leadership and oversight to assure the quality and compliance of IPC activities including: training events, data preparation and analysis events and products (including the documentation of lessons learnt).
- Provide technical guidance and training in IPC data preparation and re-analysis. Liaise with the IPC Information Support Systems Developer providing necessary technical inputs into the revision and updating of the ISS IPC with the aim to ensure the end product is user friendly and relevant to IPC Country analysis.
- · Performs other related duties as required.

- Advanced University degree in Agriculture, Economics, Nutrition, Statistics, Social Science, Agro-finance or a closely related field
- Seven years of relevant work experience in food security and vulnerability analysis including familiarity with different methodologies and indicators
- · Working knowledge of English, French or Spanish and limited knowledge of one of the other two

- Extent of relevant experience in coordinating and managing multi-disciplinary teams. Preference will be given to candidates with coordination experience obtained in multi-sector and multi-agency contexts
- Proven ability to lead training and capacity building initiatives and teaching/training skills in a multi-disciplinary context
