Organizational Setting

The Regional Office for Latin America and the Caribbean is responsible for leading FAO's response to regional priorities for food security, agriculture and rural development through the identification, planning, and implementation of FAO's priority activities in the region. It ensures a multidisciplinary approach to programmes, identifies priority areas of action for the Organization in the Region and, in collaboration with departments and divisions at Headquarters, develops, promotes and oversees FAO's strategic response to regional priorities.

RLC also advises on the incorporation of regional priorities into the Organization's Programme of Work and Budget and implements approved programmes and projects in the region, monitors the level of programme implementation and draws attention to problems and deficiencies. RLC develops and maintains relations with region-wide institutions including the Regional Economic Integration Organizations (REIOs).

The Regional Office supports regional policy dialogue on food security, agriculture and rural development issues, facilitates the emergence of regional partnerships, and supports capacity development and resource mobilization for food security, agriculture and rural development in the region.

The post is located in the Strategic Objective 2 – Increase and improve provision of goods and services from agriculture, forestry and fisheries in a sustainable manner.

Reporting Lines

The Agricultural Officer (Plant Production) reports to the Strategic Objective Coordinator (SO2), RLC and reports technically to the Agriculture Department in Headquarters, and contributes as a leader or member of one or more technical teams.

Technical Focus

Integrated and sustainable cropping systems, efficient use of scarce resources and energy, technology transfer and innovation, and agrobiodiversity in the Latin America and Caribbean region.

Key Results

Comprehensive technical, statistical, analytical and/or policy analysis services and the development of specialized tools, methodologies, systems and/or databases to support the planning, implementation/delivery and monitoring of the programme of work and related products, projects, publications, and services

Key Functions

- Plans and leads components of multi-disciplinary teams, leads and/or participates in internal committees, project teams, and working groups and/or provides specialized expertise on technical networks and/or international technical policy and/or international technical policy and standard setting bodies;
- Develops technical, analytical, monitoring and reporting frameworks, and related methodologies, tools, systems and databases etc. to support the planning, implementation/delivery and monitoring of programmes of work, projects, products and/or services;
- Designs and conducts research, data collection, validation, analysis and/or reporting activities to support the development of technical standards, international instruments, innovative approaches and strategies, new tools, technologies, technical reports/publications, and/or policy proposals as well as the provision of technical/policy/ specialist/advice and expertise;
- Responds to country requests for technical and policy assistance, provides technical advice, assistance and solutions to Decentralized Offices and provides technical backstopping to field projects;

- Collaborates in, provides technical backstopping to and ensures the quality / effectiveness of capacity development and knowledge sharing activities within member countries such as policy support, organizational development and individual learning events including preparation of related information, learning materials, on-line tools;
- Promotes international cooperation/advocates best practices, increased policy dialogue and provides technical expertise at international/intergovernmental meetings;
- Participates in resource mobilization activities in accordance with the FAO Corporate strategy.

Specific Functions

- Contribute to multidisciplinary teams and provide a vision, strategy, leadership and coherent approach on integrated and sustainable cropping systems, agrobiodiversity, efficient use of scarce resources and energy, technology transfer and innovation mainly in crops important for family farming in the Latin America and Caribbean region, drawing on corporate and international good practices, frameworks and knowledge
- Support countries, sub regions and the region in achieving results associated with their Country Programming Frameworks, Regional Initiatives and Corporate Strategic Objectives in agronomic areas
- Provide technical advice in the formulation, implementation, and evaluation of policies and programmes at all levels related to family farming and home gardens for the production of nutritious, genetically diverse and safe food crops and emergency projects to strengthen local and national food systems.
- Provide regional perspectives and priorities in support of FAO's periodic planning and programming exercises, the development of FAOs Strategic Framework, and the implementation of the regular programme in technical focus areas
- Serve as regional focal point in key technical areas and represent the organization in relevant internal and external meetings such as the CGIAR and Regional follow up to the FAO Committee on Agriculture..
- Build and maintain partnerships with key government, UN, civil society and scientific and academic organizations to achieve or enhance results and help to develop their capacities to autonomously undertake research, policy and development in integrated and sustainable cropping systems, agrobiodiversity, efficient use of scarce resources and energy and technology transfer and innovation.
- Contribute to the analysis and understanding of policy, institutional and technical causes and solutions to major agronomic trends, systematizing, publishing and disseminating this knowledge and contributing to efforts to improve associated data and statistics
- Help to optimize the contribution of agronomic knowledge to economic, social and environmental sustainability

Minimum Requirements

- Advanced university degree in agronomy or related field.
- Seven years of relevant experience in integrated and sustainable cropping systems, agrobiodiversity, efficient use of scarce resources and energy and/or technology transfer and innovation, including at least two years of field experience.
