### **Organizational Setting**

FAO Bangladesh assists the Government to develop policies, programmes and projects to address the root causes of hunger and malnutrition; to help the Government develop the agricultural, fisheries and forestry sectors and to use the environmental and natural resources in a suitable way. It participates in the development of FAO's field projects in the country and implements them in the sectors of food security, agriculture and rural development.

Meeting the Undernutrition Challenge (MUCH) builds on the success of the National Food Policy Capacity Strengthening Programme and strengthen capacities of the Government and stakeholders for the development, implementation and monitoring of cross-sectoral policy frameworks and investment plans, human resources and organizational development, resource allocation and utilization, effective policy dialogue and advocacy, and assessment and monitoring of food security trends.

The post is located in the FAO Representation in Dhaka, Bangladesh.

### **Reporting Lines**

The Senior Nutritionist reports to the FAO Representative in Bangladesh and to the MUCH Chief Technical Advisor (CTA) on technical issues.

### **Technical Focus**

Promotion of cross-sectoral policy frameworks, nutrition sensitive and food-based interventions, dietary diversity, sustainable food systems, multi-stakeholder dialogue and advocacy, institutional capacity and human resources development, and research activities to inform food and nutrition security policies and programmes.

### **Key Results**

Strengthen enabling environment, including improved capacity and governance, development, implementation and monitoring of cross-sectoral policy frameworks, programmes and investment plans, as well as research activities, for achieving food and nutrition security at country level in accordance with project objectives and the FAO Strategic Framework.

# **Key Functions**

- Plans, manages, and leads a multi-disciplinary team on nutrition (food utilization) in coordination with the Food Planning
  and Monitoring Unit (FPMU) of the Ministry of Food and with other key partner ministries in agriculture, fisheries and
  livestock, women and children, and health and family affairs;
- Provides technical and policy advice to key partner ministries, inter-ministerial food security and nutrition teams, and
  representatives of civil society and the private sector, in the development, implementation and monitoring of cross-sectoral
  and sectoral policy frameworks and investment plans, food security and nutrition programmes, and nutrition sensitive,
  food-based interventions,
- Contributes to the assessment of contributions to achieving relevant national and global food security and nutrition policy targets, such as the 7th Five-Year Plan and the Sustainable Development Goals;
- Plans, organizes and participates in capacity development activities and oversees the development of related materials
  and tools, which involves mentoring to key ministry staff and conducting training workshops, seminars and meetings on
  issues related to nutrition, food security, assessment methodologies, advocacy and sensitization, and other topics
  identified in response to national needs;
- Supervises and leads data collection, validation, analysis and reporting activities to support the development of technical standards, such as dietary guidelines, analytical tools, methods and instruments, and project's flagship publications,
- Facilitates and supports government participation in donor coordination mechanisms and other multi-stakeholder initiatives
  relevant to food security and nutrition, including the Scale-up Nutrition (SUN) and the National Information Platform on
  Nutrition (NIPN):
- Plans, organizes and participates in multi-stakeholder dialogue to identify food security and nutrition policy related research needs, develops detailed terms of reference for commissioning research, and supervises it in collaboration with inter-ministerial research supervisory committees;

  and other related fields in response to policy assistance needs and demands at country level;

  and agreements with national and international partners; and
- Performs other duties as required.
