### **Tasks and responsibilities:**

Under the overall supervision of the Sub regional Coordinator for Central Asia, SEC, direct supervision of SPL for SO2 and Land and Water Officer, in close collaboration with FAOSEC multidisciplinary team, FAOREU technical officers (climate change) and the national counterparts, the Consultant will undertake the following duties:

- Based on request, assists in the identification and formulation of field programmes and projects on sustainable natural resources management, climate change mitigation and/or adaptation;
- Assists in the formulation and delivery of capacity development strategies and activities in the areas of sustainable natural resources management, climate change mitigation and/or adaptation to government staff, and non-state actors and private sector organizations;
- Provide technical backstopping for the implementation, monitoring and reporting of national and sub-regional projects in the area of natural resources management;
- Provide support to the preparation of the project document "Integrated natural resources management in drought-prone and salt-affected agricultural production landscapes in Central Asia and Turkey" (CACILM-II GCP/SEC/294/GFF), coordinating as necessary among consultants to ensure timely completion;
- Provide oversight and support to ensure participation of FAO and tangible contributions to the works of Eurasian Soil Partnership and its Secretariat;
- Formulate new projects in the field of sustainable natural resources management, climate change mitigation and/or adaptation, as required;
- Participate in resource mobilization activities in accordance with the FAO Corporate strategy;
