Tasks and responsibilities:

Under the overall supervision of the FAO Representative in the Philippines, the direct supervision of the Asst. FAO Representative (Programme), technical supervision of the Lead Technical Officer, guidance of the National Project Coordinator, and in close collaboration with the FAO PH Programme Unit, the International Consultant will provide inputs to the project on a short term basis and contribute to the facilitation of project activities

Specific duties are as follows:

1. Conduct a desk review of the developments in the implementation of the Land Sector Development Framework (LSDF) including review of relevant reports from LMB, FMB and other concerned agencies under Component 1.
2. Provide updates on international trends/directions that may have impact in the updating of the LSDF. These should also take into consideration the LGAF, VGGT and the Global Land Indicator.
3. Facilitate and provide expert support in the implementation of a national consultation workshop on the updating of the LSDF.
4. Provide inputs to enable the update of the LSDF document, in the following areas:
 - a. Possible project and policy initiatives and timelines for the next 10 to 15 years including budget estimates that will help guide the government in pursuing the LSDF vision/mission.
 - b. Updates on the issues and challenges 'vis a vis' international trends that the government needs to address and anticipate in pursuing the long term objectives of the framework.

Candidates should meet the following requirements:

Minimum Requirements

Education: Advance University degree in Land Management and Administration or related fields

Work Experience and Knowledge:

The International Consultant should have an appropriate balance of experience and expertise in two or more of the following areas, preferably in the Philippine context:

- Tenure rights
- Legal, policy and institutional tenure framework
- Governance of tenure
- Administration tenure
- Land administration and management

- At least 5 years of work experience in two or more subject matters and areas as mentioned above
- Evaluation experience of large and complex multi-stakeholder programmes
- Excellent writing skills
- Experience of work with civil society organizations
