#### Organizational Setting

The Agricultural Development Economics Division (ESA) conducts economic research and policy analysis related to all five of the Organization's strategic objectives (food security, sustainable agriculture, poverty reduction, inclusive food systems and resilient livelihoods); ESA provides evidence-based analytical support to national, regional and global policy processes and initiatives related to food security and sustainable agriculture; and leads large programmes at country level on food security information and analysis in support of national policies.

The Integrated Food Security Phase Classification (IPC) is an innovative, global, multi-partner initiative to facilitate decision-making with improved food security analysis. The IPC is set of tools and protocols for classifying the severity and nature of food insecurity that integrates food security, nutrition and livelihood information into a clear statement about the nature and severity of food insecurity and implications for response. IPC incorporates a meta-analysis approach drawing on evidence-based analysis that includes a broad range of data sets and stakeholders.

The Senior Programme Coordinator (IPC Global Programme) will support the development and implementation of the IPC Global Strategic Programme and provides oversight and leadership to the IPC Global Support Unit (GSU).

#### Reporting Lines

The Senior Programme Coordinator (IPC Global Programme) reports to the INFORMED Programme Coordinator, under the overall guidance of the Director, ESA.

#### Technical Focus

Team leadership, technical oversight of applied food security analysis in humanitarian and development context, strategic capacity development, donor relations, and resource mobilization.

#### Key Results

Leadership and conceptual thinking for the development and implementation of comprehensive technical and analytical frameworks to support the IPC initiative, as well as, further strengthening the Global IPC multi-stakeholder partnership.

#### Key Functions

- Provides effective team leadership of the IPC GSU, supporting, coordination and facilitation of technical inputs, providing overall management support and technical oversight for the IPC Global Strategic Programme.
- Implements and monitors the IPC work programme involving the conception and development of comprehensive statistical and/or analytical frameworks including early warning, medium and long term plans and strategies, leading edge tools, methods, systems and databases, critical indicators, and/or policy models, etc.
- Oversees and reviews capacity development and analysis and reporting of IPC activities to support the development of technical standards, international instruments and/or on-going programme development as well as technical and/or policy advisory services.
- Provides technical and policy advice to Member Countries and technical support to decentralized offices in the development and implementation of the IPC programme of work.
- Plans, organizes and participates in IPC capacity development activities involving the provision of advice, technical assistance projects, training workshops, seminars, and meetings as well as oversees the development of related materials, on-line tools and information kits.
- Represents the IPC GSU at international/inter-governmental meetings and conferences, advocates strategic

- partnerships, best practices, and increased policy dialogue and develops and negotiates effective working relationships/consensus and agreements with international and national partners.
- Leads and/or participates in resource mobilization activities in accordance with the corporate strategy.

#### Specific Functions

- Manages the implementation of the multi-year IPC Global Strategic Programme (2014-2018), in consultation with the IPC Global Steering Committee
- Leads the implementation of the IPC programme in consultation with relevant FAO staff and IPC Global Partners as endorsed by IPC Steering Committee;
- Manages and oversee the work of the IPC Global Support Unit (GSU), ensuring a coherency in standards and approach globally and across regions;
- Coordinates and oversee technical development and quality assurance activities included in the multi-year work plan endorsed by the IPC Global Steering Committee;
- Promotes country and regional level partnerships as a mechanism to increase capacity to deliver high quality IPC products;
- Reports quarterly to the IPC Steering Committee on progress against plans, agreed outputs and challenges;
- ensure implementation of a standard lessons learning process including feedback;
- Oversees the development and production of IPC capacity-building and communication products.
