#### **Organizational Setting**

The Forestry Policy and Resources Division leads FAO's work in promoting sustainable forest management and providing leadership on the environmental, social and economic dimensions of forestry, including its contributions to poverty reduction and food security and nutrition. It liaises with member countries, civil society and the private sector in aspects ranging from development of effective forest policies to forest conservation and management issues, and strengthens the role of forests in climate change mitigation and adaptation. The Division also collects, analyses and disseminates information on the world's forest resources and on the production, trade and consumption of wood and non-wood forest products.

The post is located in the REDD+ team which supports developing countries in their efforts to mitigate climate change through the implementation of REDD+ activities while contributing to national sustainable development.

### **Reporting Lines**

The Forestry Officer reports to the REDD+ Coordinator, under the overall guidance of the Director, FOA. The incumbent will work closely with experts from REDD+ and National Forest Monitoring teams and other FO forestry experts in Headquarters and other regions, mostly with the FAO Regional Office for Latin America and the Caribbean (RLC), the sub-regional office for Mesoamerica (SLM) and FAO's subregional Office for the Caribbean (SLC).

### **Technical Focus**

The incumbent will lead, provide technical guidance and coordination for FAO REDD+ global thematic groups working on REDD+ forest governance (including safeguards, land tenure and REDD+ legal issues) and will support the work on implementation of REDD+ actions, while ensuring technical linkage with other FAO teams for coordinated support. In addition, the incumbent will support the technical and operational delivery of the FAO REDD+ Programme at the country level providing liaison between the REDD+ coordinator and REDD+ thematic experts based in Headquarters and regions to ensure technical consistency and supporting the Organisation's coordination efforts.

Comprehensive technical and policy expertise to support the planning, development and implementation of Departmental/Division programmes, projects, products and services in accordance with Departmental/Division objectives and FAO Strategic Objectives.

- Identifies synergies between REDD+ efforts and relevant land use mitigation actions, ecosystem based approaches, forest management and restoration at country and global level, draws lessons learnt and helps share information and knowledge among countries;
- Develops and manages project activities to support country implementation of REDD+ actions ensuring the linkages and contribution of the enabling environment at the country level in accordance with UNFCCC provisions, Nationally Determined Contributions and FAO Strategic Objectives;
- Contributes to the development of tools, methods and approaches for REDD+ National Forest Monitoring Systems (NFMS), and for REDD+ implementation, bringing in country perspectives;
- Provides REDD+ specific technical programming, implementation and monitoring support to partner countries
  especially in Latin America and the Caribbean, as well as to FAO decentralized offices and relevant units in
  Headquarters;
- Supports collaboration and partnerships with other REDD+ agencies, actors and initiatives at regional and national levels such as UNDP, UNEP and the World Bank;
