**Organizational Setting**

Through its Country Offices, or FAO Representations, FAO assists governments to develop policies, programmes and projects to address hunger and malnutrition, and provides technical support for the sustainable development of their agricultural, fisheries and forestry sectors and to respond to crises. The activities of the FAO Country Offices include design and implementation of country-tailored field programmes, liaison with local donor representatives, and active public awareness-raising and outreach activities related to FAO initiatives such as the World Food Day.

The position is located in the FAO Representation in Yemen

**FAO International Consultants and Call purpose**

Given the current situation in Yemen in terms of being one of the biggest humanitarian crises in the world and one of the four countries at risk of famine in 2017, FAO needs to increase its visibility and communicate widely to all stakeholders its work in support of the affected population in the country.

It is against the above background that FAO is recruiting a Communications Consultant to support the FAO Representation in Yemen. Under the overall supervision of the FAO Representative in Yemen and the direct supervision of the Deputy FAO Representative in Yemen, the Communication Consultant will provide communication support to the Yemen emergency programme. In regular consultation and coordination with the Regional Communication Officer in FAORNE, TCE Outreach team and OCC, the incumbent shall ensure coherence with FAO's corporate communication policy and operational guidelines for all communication and information outputs

**Reporting Lines**

The communication consultant will report to the Deputy FAO Representative in Yemen under the overall supervision of the FAO Representative in Yemen

**Specific functions**

- Develop and produce communication products for the FAO emergency and rehabilitation programme in Yemen (eg. Situation reports, key messages, briefs, brochures, talking points, success stories, presentations and visibility material)
- Draft and review text in English, and coordinate the design, translation, printing and distribution process.
- Facilitate media relations in country, including drafting of press releases for appropriate clearance, developing and maintaining a network of media contacts in country, organizing press conferences/briefings, as appropriate both in English and Arabic.
- Lead the development and implementation of a yearly communication plan for the FAO (emergency and rehabilitation) programme in Yemen and other specific communication plans for projects as needed.
- Liaise with relevant colleagues in headquarters and the regional office in Cairo, TCSR reporting and outreach team, and OCC media team to facilitate exposure of FAO Yemen's work and needs in the food security/agriculture sector, ensuring accuracy/relevance of content developed
- Undertake travel to affected areas, as necessary, and ensure collection/production of stories, interviews, photos and videos;
- Liaise with OCHA, RC, HC for key messages to be shared with the donors and contribute to enhancing and promoting FAO and donor visibility related to specific donor-funded projects, as well as general visibility initiatives on FAO programmes (bulletins, newsletters, posters, etc.).

- Ensure FAO is adequately represented in the OCHA Humanitarian Communications Group and other relevant fora/meetings and work in close collaboration with OCHA Reporting and Public Information teams and UN Communication teams to ensure sectoral priorities, the needs of affected populations and FAO are well represented;
- Compile, write, edit and review progress, interim and final reports. During this process, the Communication/Reporting Officer will adhere to FAO's Reporting and Editorial Guidelines and templates to ensure consistency and correct use of language.
- Perform other related duties as required

- Five years of relevant experience in performing similar functions.
- Working knowledge of English. Knowledge of Arabic is an advantage

- Knowledge of Adobe Creative Suite, particularly InDesign and Photoshop is desirable
