Organizational Setting

The main aim of the FAO country offices, which are headed by an FAO Representative, is to assist governments to develop policies, programmes and projects to achieve food security and to reduce hunger and malnutrition, to help develop the agricultural, fisheries and forestry sectors, and to use their environmental and natural resources in a sustainable manner.

The FAO Representation in Lebanon is responsible for leading the administration and coordination of implementation of projects with the technical and operational support of the FAO-RNE and HQ.

FAO Lebanon is implementing several projects to enhance the resilience of small-scale farmers by supporting a range of activities including investments in land reclamation and water reservoirs, cash transfer, farmer field schools, rehabilitation of agriculture technical schools and protection of agriculture and livestock assets. These projects are funded by a several donors and implemented by FAO in partnership with international and national partners.

In light of its expanding project portfolio, the FAO Office in Lebanon is seeking to recruit an experienced Chief Technical Adviser to coordinate the implementation of all donor-funded projects and to assist the Office in its ongoing resource mobilization efforts.

The post is located in the FAO Representation in Beirut, Lebanon.

Reporting Lines

The Chief Technical Adviser reports to the the FAO Representative (FAOR) under the technical supervision of the relevant Divisions at FAO Headquarters.

Technical Focus

The incumbent will provide high-level operational and technical guidance to projects implemented by FAO Lebanon under the Lebanon Crisis Response Plan (LCRP). The incumbent will ensure the successful delivery of all projects and will assist the FAOR in resource mobilization efforts under the LCRP

Key Results

Leadership and technical expertise for the planning, development and implementation of Programmes of work, projects, related-products, and services in accordance with FAO Strategic Objectives.

Key Functions

- Leads the development, implementation and evaluation on technical issues of assigned programmes/projects; directs review of relevant documents and reports; identifies priorities, liaises with relevant parties; identifies and initiates follow-up actions;
- Coordinates programmes and reviews the assessments of issues and trends for the implementation of programmes and projects and the preparation of impact evaluation or equivalent studies;
- Supervises preparation of various written outputs, e.g. background papers, analysis, substantial sections of reports and studies, inputs to publications;
- Directs substantive support to consultative and other meetings, conferences, to include proposing agenda topics, identifying participants, preparation of documents and presentations;
- Manages outreach activities; designs and conducts training workshops, seminars, makes presentations on assigned topics/activities;
- Leads field missions, including provision of guidance to external consultants, government officials and other parties;
- Provides advice to develop policies and strategies as well as national protocols and guide lines for projects with

specific domains related to FAO's work

Specific Functions

- Directs review of relevant documents and reports; identifies priorities, liaises with relevant parties; identifies and initiates follow-up actions;
- In consultation with all stakeholders, develops the detailed implementation plan indicating the activities to be implemented, the modality of implementation and the funds required for each; manages operations and activities and amends this plan as deemed necessary;
- Plans and oversees the provision of all FAO inputs, including provision of specifications; manages the process for the purchase of equipment and supplies, and their maintenance;
- Engages in stakeholders consultation, including at community level;
- Prepares business plans on new/alternative economic and entrepreneurial activities;
- Prepares progress reports during the project life and a terminal end of project report as well as an end of assignment report;
- Performs other related duties as required
