Organizational Setting

The Trade and Markets Division monitors and analyses trends in international, regional and national agricultural commodity markets, collecting and disseminating comprehensive market and policy information concerning the major traded commodities and those important to food security. It undertakes forward looking studies and is responsible for the publication of the *OECD-FAO Agricultural Outlook*. The Division analyses global issues that affect agricultural trade, including policy analysis of trade measures and agreements, and provides technical support and capacity building to member states in all these areas. Through its Global Information and Early Warning Service, the Division is also responsible for FAO's early warnings on food shortfalls. The Division houses the secretariats of the Committee on Commodity Problems (CCP), nine Intergovernmental Commodity Groups (IGGs) and the Agricultural Market Information System (AMIS).

Reporting Lines

The Commodity Database Analyst reports to the Team Leader, Medium-Term Outlook and Market Analysis Team, under the overall guidance of the Division Director.

Technical Focus

Perform data management including, but not limited to, compiling and maintaining databases and data quality assurance for the FAO Commodity Simulation Model (COSIMO).

Tasks and responsibilities

- In cooperation with team members, review the existing COSIMO database system with respect to its potential for improvement of compilation procedures and data quality. Develop a plan to implement the findings.
- Specifically, consider procedures for data consistency verification and automated adjustments to ensure market balances.
- Develop data aggregation routines that dynamically align the database with the flexible COSIMO structure.
- In preparation for the 2018 OECD-FAO Agricultural Outlook, update the COSIMO database using multiple data sources such as FAOSTAT, XCBS, COMTRADE (data dissemination tool available in FAO) and applying the quality assurance procedures described above.
- Develop documentation and training materials to enable model analysts to update commodity and/or country specific database sections.
- Communicate all developments to the team members in the regular meetings.

Minimum Requirements

- For Consultants: Advanced university degree in computer science, statistics, economics, agricultural economics or related area

- Working knowledge of English, French or Spanish and limited knowledge of one of the other two or Arabic, Chinese, Russian
