### Organizational Setting

The Agricultural Development Economics Division (ESA) conducts economic research and policy analysis related to all five of the Organization's strategic objectives (food security, sustainable agriculture, poverty reduction, inclusive food systems and resilient livelihoods). ESA provides evidence-based analytical support to national, regional and global policy processes and initiatives related to food security and sustainable agriculture.

The Economic and Policy Analysis of Climate Change (EPIC) programme works with governments, research centres, universities and other institutional partners to support the transition to Climate-Smart Agriculture (CSA) by using sound economic and policy analysis.

### Reporting Lines

Under the overall supervision of the team leader of EPIC, and under the direct supervision of the Economist coordinating the analysis of agricultural policies and climate change.

### Technical Focus

The Economist will support economic and policy analysis of climate change in developing countries. She/he will conduct relevant policy analysis to enable developing countries to design agricultural policies in coherence with their effort to put their economic development on a low - emission and climate-resilient pathway. She/he will be familiar with economics analytical tools, such as public expenditure, climate change economic analysis, adaptation cost estimates, etc. She/he will work in close coordination with the other members of the team, as well as provide strategic support and policy advice to the senior economist. Other specific aspects are:

- Experience of applied economics in the context of climate change, agricultural and food policy;
- Broad knowledge of current political economic conditions in countries-in-transition and developing countries, and ability to present the key results in front of public audiences;
- Experience in organizing missions and seminars, conferences in developing countries;
- Preferably, experience in communicating with government officials in developing countries

### Tasks and responsibilities

- Provide technical and policy advice to selected countries in the development and implementation of their programmes of work related to agricultural and food policy analysis in connection with climate change;
- Contribute to the development of technical products, in particular economic analysis and produce related evidence-based policy guidance and support on climate change in relation with markets, food security and trade policies;
- Provide technical backstopping services to monitor agricultural and climate change policy analysis and capacity development support to government counterparts and other selected national partners.
- Conduct analytical studies of climate change and agricultural policy issues, including (i) trade and domestic policies that influence climate change affecting supply and prices in commodity markets, (ii) climate change and stock policies and (iii) value chain and market analysis in the context of climate change, as well as (iv) other emerging issues, such as impacts on food supplies and prices on climate change.

### CANDIDATES WILL BE ASSESSED AGAINST THE FOLLOWING

#### Minimum Requirements

- Advanced university degree in economics, agricultural economics, environmental economics, political science or any related field;
- Three years of relevant experience in economic analysis of food and agricultural issues, (indicatively, agricultural economics, climate change economics, food policies, agricultural price policies, agricultural inputs policies, environmental economics);

- Working knowledge of English, and limited knowledge of French, Spanish, Russian , Arabic or Chinese
