### Organizational Setting

The Trade and Markets Division monitors and analyses trends in international, regional and national agricultural commodity markets, collecting and disseminating comprehensive market and policy information concerning the major traded commodities and those important to food security. It undertakes forward looking studies and is responsible for the publication of the OECD-FAO Agricultural Outlook. The Division analyses global issues that affect agricultural trade, including policy analysis of trade measures and agreements, and provides technical support and capacity building to member states in all these areas. Through its Global Information and Early Warning Service, the Division is also responsible for FAO's early warnings on food shortfalls. The Division houses the secretariats of the Committee on Commodity Problems (CCP), nine Intergovernmental Commodity Groups (IGGs) and the Agricultural Market Information System (AMIS).

### Reporting Lines

The Trade Policy Consultant reports to the Team Leader, Trade Agreements and Agricultural Trade Policy, under the overall guidance of the Division Director.

### Technical Focus

The consultant will contribute to the outputs of the Trade Agreements and Agricultural Trade Policy team, providing technical support to FAO member countries for the effective formulation of trade policies and participation in trade negotiations through the provision of the evidence base, capacity development and facilitation of fora for policy dialogue.

### Tasks and responsibilities

In close collaboration with all team members the consultant is expected to:

- Monitor the multilateral trade negotiations at the World Trade Organization (WTO) and regional and/or bilateral trade negotiations to prepare analytical studies/reports on the implications of trade policy developments on agricultural markets and food security;
- Analyse relevant data and information, synthesize literature, and support the preparation of knowledge products such as working papers, technical notes and briefs on agricultural trade policy, trade negotiations and the relationship between trade and food security;
- Plan and execute activities involving technical and organizational support in response to country requests with regard to the design and implementation of agricultural trade policies and contribute to the formulation and delivery of trade-related support under various projects;
- Participate in missions to FAO member countries to provide technical backstopping on projects and related activities;
- Develop tailored training modules for the e-learning and face-to-face courses on trade, including materials based on relevant case-studies, country examples, materials for the design of interactive scenarios etc. and contribute to delivery of training and defining future capacity development events to ensure sustainability of learning;
- Support stakeholder engagement activities, including dialogue events with relevant ministries and partner organizations to develop trade activities and project proposals based on analytical findings;
- Facilitate the organization of workshops and seminars in collaboration with concerned partners;
- Perform other duties as required.

### CANDIDATES WILL BE ASSESSED AGAINST THE FOLLOWING

#### Minimum Requirements

- Advanced university degree in Economics, Agricultural Economics, Public Policy, Business or related field;
- At least five years of relevant experience with agricultural economics and/or trade policy analysis, trade negotiations and inter-governmental coordination on trade and markets issues;
- Working knowledge of English and limited knowledge of Arabic, Chinese, French, Russian or Spanish.
