Organizational Setting

CSAI is responsible for providing the facilities and sustainable services to the FAO Headquarters building and to the FAO Decentralized Offices. It aims to maximise efficiencies and reduce the environmental impact of FAO resulting from operations.

Reporting Lines

The consultant will provide advice and support to the Focal Point of Corporate Environmental Responsibility of FAO and, for the organization of large events, directly to other departments. The consultant will also act as Alternate to the Focal Point when dealing with other UN Agencies in the field of Corporate Environmental Responsibility.

Technical Focus

The consultant will assist in implementing the FAO Corporate Environmental Responsibility Strategy 2017-2020 and further implement the Environmental Management System in Headquarters and Decentralized Offices. The implementation of the Strategy as well as the EMS requires the liaison with Italian Authorities (Municipality etc.) and Italian Contractors.

Tasks and responsibilities

- Collect and analyze data for FAO's Greenhouse Gas emission reports for Headquarters and Decentralized offices.
- Maintain and update the FAO Environmental Management System by tracking the following activities: catering, heating, ventilating and air conditioning (HVAC) systems, printing and publishing, conference services, waste management, travel and procurement.
- Develop written proposals to improve sustainable waste management throughout the Organization.
- Develop written proposals and assist in implementing measure to reduce the environmental impact of facilities activities, large conferences and events.
- Identify green requirements for goods and services to include in tender technical specifications.
- Draft the FAO's Corporate Environmental Responsibility Report yearly report.
- Perform other duties as required.

Furthermore the consultant will:

- Represent CSAI when briefing the FAO Country Representatives;
- Liase with other FAO Climate Change department in particular upon relevant to Climate Change issues.
