Organizational Setting

The Plant Production and Protection Division (AGP) promotes the sustainable intensification of crop production (SCPI). This requires the integration and harmonization of all appropriate crop production policies and practices within the broader framework of sustainable food and agriculture that aims at enhancing productivity; natural resources conservation; rural livelihoods and resilience.

The post is located in the Ecosystem Approach to Crop Production Intensification Team (AGPME), one of the six teams in the Division. AGPME provides advice, technical support and guidance to countries aimed at maintaining and enhancing ecosystem services as essential components of sustainable farming systems. The incumbent is part of a Team of technical specialists that includes expertise on, cropping systems, plant nutrition, Integrated Pest Management soil health, and various aspects of agro-biodiversity to deliver a programme of work on SCPI that emphasizes sustainable agricultural production systems addressed to smallholder farmers

Reporting Lines

The Agricultural Officer reports to the Team Leader, AGPME.

Technical Focus

Project management, reporting and coordination of technical aspects with emphasis on monitoring and assessment of land degradation in pastoral areas with a view to influence policies and informed decisions to address land degradation and promote sustainable land management (SLM) in rangelands and grasslands.

Research, technical analysis, and project related services to support the delivery of programme projects, products, and services.

Key Functions

- Researches and analyzes technical, social, economic, environmental, institutional, and technology related information, data and statistics and/or related policy issues to support the delivery of programme projects, products and services.
- Produces a variety of technical information, data, statistics and reports as well as input for technical documents and web pages.
- Provides technical support/analysis to various assessments, studies and initiatives and provides technical backstopping to field projects.
- Collaborates in the development of improved/updated tools, systems, processes, and databases.
- Participates on multi-disciplinary teams, and/or leads working groups/teams collaborates with other departments and agencies on work groups and committees and promotes best practices.
- Collaborates in, provides technical backstopping to and ensures the quality / effectiveness of capacity development activities within member countries such as policy support, organizational development and individual learning events including preparation of related information, learning materials, on-line tools.
- Promotes knowledge sharing and best practices at international meetings and conferences and influences partners in stakeholder consultations.
- Supports resource mobilization activities in accordance with the FAO Corporate strategy

Specific Functions

- Facilitates the mainstreaming of SLM best practices in pastoral areas into national and international partner organizations' policy frameworks while ensuring high level of collaboration among participating institutions at various levels.
- Contributes to the development of the pastoral areas land degradation assessment methodology and facilitates the recognition and adoption of the methodology in relevant international mechanisms while coordinating and working with other UN agencies.
- Coordinates with other FAO multi-disciplinary teams and working groups to ensure collaboration promoting best practices, capacity development and knowledge sharing on pastoral areas for increased food security, natural resources conservation, resilience and sustainable livelihoods.
- In project countries liaise with government agencies and FAO country representations and regularly advocate on behalf of the project including through position papers and policy briefs on best practices in support of global environmental benefits including ecosystem services.
- Coordinates and closely monitors implementation of project activities, assists in tracking project's progress and ensuring timely delivery of inputs and outputs including those led the executing partner.

- Advanced university degree in natural resources management, natural resource governance, environmental management, environmental economics, or related field.
- Five years of relevant experience in pastoral resource governance, pastoral policy advocacy, land management and land degradation in grasslands and rangelands.
- Working knowledge of English and limited knowledge of French, Spanish or Russian.
