TCI is a multidisciplinary division composed of three regionally focused services, namely Africa Service, Asia and the Pacific Service, and Europe, Central Asia, Near East, North Africa, Latin America and the Caribbean Service. ]

Provision of technical expertise/assistance and support to capacity development for (i) the design of investment operations, in collaboration with country stakeholders and cooperating partners, to mobilize resources for food security, agriculture, rural development, natural resource management and agro-processing; and (ii) implementation support and evaluation of investment operations, in accordance with the FAO Strategic Framework.

- Promotes knowledge sharing and best practices at international meetings and conferences, and interacts with international and national partners.
- Establishes, promotes and maintains relationships with relevant Strategic Programmes, FAO Technical Units and Decentralised Offices in order to ensure best synergies between investment, policy and innovation work in support to member countries.
- Supports resource mobilization activities in accordance with the FAO Corporate strategy.

- Participates in the identification and analysis of agricultural investment-related policy issues.
- Supports the development of knowledge products, including analytical work and practical tools, related to agribusiness, marketing and value chain development.

- Provides guidance and advice to junior staff.
