Organizational Setting

The Investment Centre Division (TCI) promotes investment in food security, agriculture, rural development, natural resource management and agro-processing in developing countries and countries in transition, assisting governments and country stakeholders, main development partners, in particular international financing institutions with the strategic planning and implementation of their investments to achieve food security and nutrition, make agriculture, forestry and fisheries more sustainable and productive, reduce rural poverty, make food value chains more efficient and inclusive and promote climate change adaptation and/or mitigation.

TCI is a multidisciplinary division composed of three regionally focused services, namely Africa Service (TCIA), Asia and the Pacific Service (TCIB), and Europe, Central Asia, Near East, North Africa, Latin America and the Caribbean Service (TCIC).

The post is located in TCIB.

Reporting lines

The Livestock Officer reports to the Chief, Asia and the Pacific Service.

Technical Focus

Design, implementation support and evaluation of investment operations (projects and programmes) in food security, agriculture, rural development, natural resource management and agro-processing as well as strategic and policy work, with a focus on sustainable livestock management, including livestock production and economics, animal nutrition and forage development, animal genetic resources improvement and management, animal health and advisory services, development and capacity building of producers and producers' institutions, value chains development, functionality of markets and private sector engagement, environmental services and waste management, and biological diversity, in addition to addressing climate change, resilience, and risk management.

Key Results

Provision of technical expertise and capacity development for (i) the design of livestock investment policies and operations, in collaboration with country stakeholders and cooperating partners, to mobilize resources for food security, agriculture, rural development, natural resource management and agro-processing; and (ii) implementation support and evaluation of investment operations, in accordance with the FAO Strategic Framework.

Key Functions

- Participates in, and eventually leads multidisciplinary teams to assist governments in the identification and preparation of investment operations in the fields of food security, agriculture, rural development, natural resource management and agro-processing, and participate in pre-appraisal and appraisal missions.
- Participates in, and eventually leads multidisciplinary teams for the implementation support and the preparation of final evaluation of investment operations.
- Provides technical expertise for the preparation of food security, agriculture, rural development, natural resource management and agro-processing studies and strategies, and in the formulation of national sector and/or sub-sector investment plans and programmes.
- Supports the development of inclusive and sustainable food systems, involving producers, their organizations, other private sector actors, civil society organizations and government.
- Formulates and delivers capacity development strategies and activities in the areas of food security, agriculture, rural development, natural resource management and agro-processing investment support to government staff, and non-state actors including private sector organizations.
- Prepares reports in accordance with government and financing partners' requirements.
- Provides support in task organization, selection of consultants, preparation of terms of reference and in ensuring the quality of outputs.
- Promotes international cooperation and collaboration leading to new investment opportunities and cooperative agreements, advocates best practices and effective policy dialogue and provides technical expertise at international meetings.
- Establishes, promotes and maintains relationships with relevant Strategic Programmes, FAO Technical Units and Decentralised Offices in order to ensure best synergies between investment, policy and innovation work in support to

member countries.

- Participates in resource mobilization activities in accordance with the FAO Corporate strategy.
- Provides guidance and advice to junior staff.

Specific functions

- Provides contributions to food security, agriculture, rural development, natural resource management and agro-processing national or regional strategies, plans and operations for their investment implications, technical, financial, social and environmental feasibility and compliance with national policies and priorities.
- Assesses the constraints and opportunities for enhancing the sustainable management of livestock systems with emphasis on sustainable livestock production and processing, social and economic impact, strengthening local institutions and organizations, including the participation of stakeholders and users, relationships to natural resource based livelihoods, waste management, climate change adaptation and mitigation, biodiversity conservation and disaster risk reduction and disaster management.
- Participates in the design of livestock and livestock activities and components of investment operations to improve the sustainable management of livestock systems, including livestock production and productivity, animal feed and animal genetic resources management, pasture and rangeland management, animal health management, herd and livestock management, and commercialization and value chain analysis.
- Provides technical expertise on the social and environmental sustainability of livestock production and processing activities including impact on climate change of existing livestock and farming, livelihoods and resource use systems, and helps defining the technical parameters for financial and economic analysis including in value chain.

Minimum Requirements

- Advanced university degree in animal production and animal science or a related field
- Seven years of relevant experience in planning and implementing sustainable livestock and agricultural development projects and programmes, including experience in the formulation and/or implementation of food security, agriculture, rural development, natural resource management and agro-processing investment operations in developing countries and/or countries in transition
- Working knowledge of English, French or Spanish and limited knowledge of one of the other two or Arabic, Chinese or Russian

- Extent and relevance of experience in participating in multidisciplinary teams for the preparation of strategies and sector studies as well as formulation, implementation support or evaluation of food security, agriculture, rural development, natural resource management and agro-processing investment operations, with a focus on sustainable livestock production and processing aspects
- Extent and relevance of experience in investment design, implementation support and evaluation procedures of FAO's main development partners, in particular the World Bank, the International Fund for Agriculture and Development (IFAD), the European Bank for Reconstruction and Development (EBRD)
- Relevance of experience in capacity development for the design and implementation of food security, agriculture, rural development, natural resource management and agro-processing investments
- Demonstrated experience in dealing with government officials, development partners and other country stakeholders;
- Demonstrated capacity to write technical reports in English
- Relevance of experience in Asia and the Pacific region
