Support to and participation in work programmes related to the post-harvest systems management with a focus on reduction of food loss and food waste. Strengthen food systems, through technical, economic, social and policy support targeted to the development of micro, small and medium agro-industry and post-harvest systems management.

Comprehensive technical, statistical, analytical and/or policy analysis services and the development of specialized tools, methodologies, systems and/or databases to support the planning, implementation/delivery and monitoring of the programme of work and related products, projects, publications, and services.

Key Functions

- Plans and leads components of multi-disciplinary teams and short term work groups, leads and/or participates on Division/Departmental teams, participates on Organization-wide committees, project teams, and working groups and provides specialized expertise on international technical networks and or technical policy and standard setting bodies.
- Develops technical, statistical, analytical, monitoring and reporting frameworks, and related tools, methodologies, systems and databases etc. to support the planning, implementation/delivery and monitoring of the programmes of work, products, projects, and services.
- Designs and conducts research, data collection, validation, analysis and/or reporting activities to support the development of technical standards, international instruments, innovative tools and methodologies, flagship publications/technical reports and/or policy proposals as well as the provision of technical specialist and/or policy advice and expertise.
- Responds to requests and provides technical/policy advice, assistance and solutions to Regional, Sub-Regional, and Country Offices and provides technical backstopping to field projects.
- Promotes international cooperation and collaboration, advocates best practices and increased policy dialogue and provides technical expertise at international meetings and conferences.
- Collaborates in capacity development activities involving knowledge sharing, the organization of training workshops, seminars, and meetings as well as the development of related materials and on-line tools and information kits.

Participates in resource mobilization activities in accordance with Corporate strategy and Departmental plans.

Specific Functions

- Contributes to work on micro, small and medium scale agro-industry development; post-harvest systems management and food loss and waste reduction, toward improving food security, income generation and nutrition in Member Countries, drawing on corporate and international good practices, frameworks and knowledge.
- Develops normative products as well as advocacy products on food loss and food waste reduction designed to enhance global knowledge and understanding about the issues.
- Contributes to the design and implementation of activities, programmes and projects related to food and postharvest systems development, and food loss and waste, including technical support and capacity building geared toward strengthening local, national and regional food systems.
- Prepares evidence-based analyses on technical, behavioural and economic issues of relevance to food and postharvest systems development with a focus on food loss and food waste.
- Contributes to the analysis and understanding of policy, institutional and technical causes and solutions for postharvest systems development and food loss and food waste and their implications for nutrition, systematizing, publishing and disseminating this knowledge and contributing to efforts to improve associated data and statistics.
- Designs strategies and programmes geared toward enhancing the capacity and competitiveness of micro, small and medium agro-enterprises.
- Participates in international meetings as well as regional and national workshops.
- Performs other duties as required.

Minimum Requirements

- Advanced University degree in food science, food technology, post-harvest management, food engineering or related subject.
- Seven years of relevant experience in agro-industry and/or post-harvest management including reducing food losses and food waste under tropical/sub-tropical conditions with emphasis in at least two of the following areas: post-harvest systems management, value addition, food product development, food quality and safety management, food loss and food waste reduction.
- Working knowledge of English, French or Spanish and limited knowledge of one of the other two or Arabic, Chinese, Russian.
