Organizational Setting

The Climate and Environment Division assists member countries in their responses towards the challenge of climate change, including the mitigation of climate change, as well as the development of adaptive capacities of agriculture, fisheries and forestry to the effects of climate change. It provides a coordination role on climate change and related climate smart agriculture issues. The Division also serves as the focal point for a multidisciplinary and global approach to bioenergy.

The post is located in the National Climate Change Action Team.

Reporting Lines

The Senior Natural Resources Officer reports to the Director of the Climate and Environment Division.

Technical Focus

The Senior Officer will serve as coordinator of the project 'Strengthening National Adaptation Planning capacities for Food Security and Nutrition' (GCP/GLO/921/GQC, funded by the Provincial Government of Québec) and be responsible for the planning, organization and operational management of the project.

Leadership and technical policy expertise for the planning, development and implementation of departmental / division Programmes of work, projects, products, services in accordance with FAO Strategic Objectives.

Key Functions

- Plans, manages, or leads highly specialized or multidisciplinary teams, leads, coordinates, and/or participates in organization-wide, cross-departmental committees, project teams, and working groups, and/or provides technical leadership/secretariat services on technical networks and/or international technical policy and standard setting bodies;

 partnerships, advocates best practices and increased policy dialogue and develops and negotiates effective
 working relationships/consensus and agreements with international and national stakeholders;
- Leads and/or participates in resource mobilization activities in accordance with the FAO corporate strategy.

- Ensures overall coordination, management and technical quality of the planning and implementation, administration and reporting of the project GCP/GLO/921/GQC in collaboration with FAOs participating departments and external partners;
- Coordinates planning, financing and implementation of the country projects in Haiti and Senegal, in collaboration
 and coordination with other development partners to ensure proper coordination, division of labour and synergies;
- Leads networking, collaboration and with different international and national programmes, stakeholders and partners to identify needs and opportunities related agricultural adaptation in the context of food security and overall economic development;
- Engages on an ongoing basis with project counterparts in the Quebec Provincial Government, and the Quebec academic institutions partnering with FAO for this project;
- Ensures that gender aspects are included in all steps of the project;
- Provides technical and managerial guidance to HQ and national staff and experts in the country projects, interacts
 with international partners and national partners and stakeholders and promote information dissemination of
 results:
- Ensures the project GCP/GLO/921/GQC articulates with other ongoing projects, in particular those implemented by the FAO Mitigation of Climate Change in Agriculture (MICCA) and Integrating Agriculture in National Adaptation Plans (NAP) teams;
- Ensures the project is in line with FAO's strategic objectives and contributes to national and international objectives and commitments such as the Paris Agreement and Agenda 2030 and the Sustainable Development Goals (SDGs);
- Ensures the results of the project are shared with the United Nations Framework Convention on Climate Change (UNFCCC) and Intergovernmental Panel on Climate Change (IPCC) communities, and other international relevant initiatives such as the Climate and Clean Air Coalition (CCAC), the Partnership on Transparency in the Paris Agreement (PATPA) and the Global Research Alliance on Agricultural Greenhouse gases (GRA).

- Advanced university degree in agronomy, environmental science or related field with academic and professional specialization in climate science or related field;
- Ten years of relevant experience in natural resources project management in relation with the Rio Conventions, in particular UNFCCC and UNCCD, including on mitigation/adaptations interventions in the agriculture sector such as Nationally Appropriate Mitigation Action (NAMA) and NAP;
- Working knowledge of English, French or Spanish and limited knowledge of one of the other two or Arabic, Chinese, Russian.

- Extent and relevance of experience in writing technical reports and scientific publications in both English and French languages on a broad range of climate change mitigation and adaptation and agriculture and food security issues is considered a strong asset;
- Extent and relevance of experience in planning and implementation of programmes related to natural resources in development organizations;
- Demonstrated scientific background in line with agriculture and climate change, at national and international levels;
- Demonstrated results-based management capabilities with an ability to manage programmes, budgets and human resources efficiently under shifting priorities;
- Demonstrated ability to mobilize additional resources;
