The function is located in the Climate, Energy and Tenure Division (NRC). NRC assists member countries in their responses towards the challenge of climate change, including the adaptation and mitigation of climate change, as well as the development of adaptive capacities of agriculture, fisheries and forestry to the effects of climate change. It provides a coordination role on climate change and related climate smart agriculture issues. The Division also serves as the focal point for a multidisciplinary and global approach to bioenergy as well as undertaking work and providing support and guidance on tenure issues. The function forms part of the project "Integrating Agriculture in National Adaptation Plans (NAPs)", operated jointly with UNDP.

The Natural Resources Officer, Climate Change, reports directly to the Senior Natural Resources Officer, NRC.

- Supports FAO's engagement in the UNFCCC and related international processes including COP 21 follow-up and preparations for COP 22 and beyond, with particular emphasis on adaptation strategies and planning;
- Conducts advocacy and build efficient relationships and partnerships with key international stakeholders including UNFCCC, Least Developed Country Expert Group (LEG), Adaptation Committee (AC), the Global Environment Facility (GEF) and the Green Climate Fund (GCF);
- Conducts resource mobilization activities to broaden scope and outreach of this project and FAO's global and country support on climate change, adaptation and National Adaptation Plans (NAPs).
