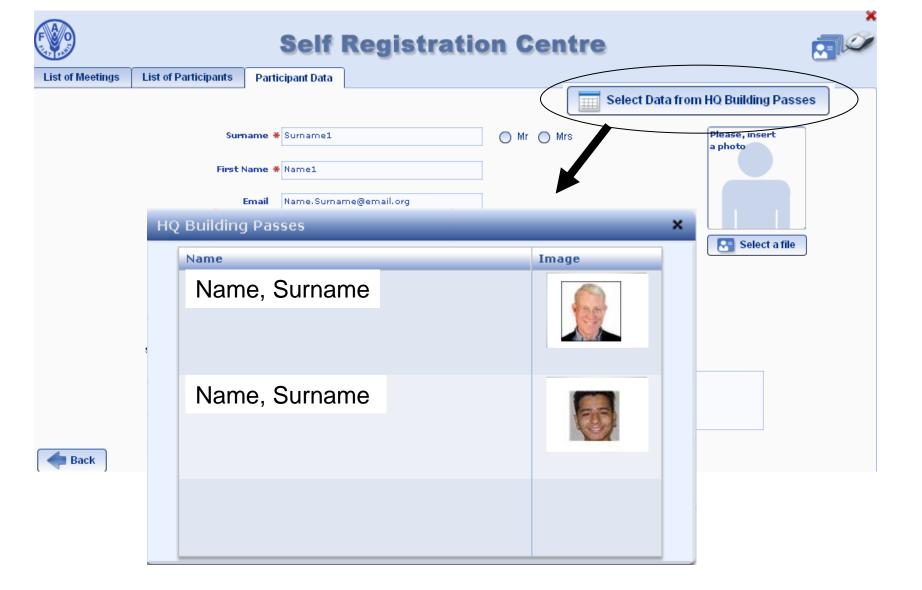

Upload a photo: A digital photo should be uploaded for each participant. The colour photograph in digital format (JPG, JPEG, GIF) should not to exceed 100 kb and size 24 mm (width) x 32 mm (height) or 195 pxls (width) x 255 pxls (height). It should be recent (maximum 6 months) and meet the following requirements:

- a) Full frontal view of face, with eyes open
- b) No shadows on the face or background
- c) A plain white background.
