- *MUTUAL AGREEMENT WITH FOLLOWING TERMS AND CONDITIONS* Mutual Agreement.

   Farmer agreed to grow ....... Crop with his own irrigation facility.
   Farmer should follow the instructions given by the company extension officers for growing the crop,

   2. ntract Farm harvesting, grading and other technical guidance.
- 3. Sowing should be done as per the company decided date.
- 4. Farmer should do the grading as per the company norms and greens should be brought to the place decided by the company. If grading is not done properly company's decision will be the final.
- 5. For any reason farmer should not stop or obstruct the buying vehicle. Unnecessarily if the farmer incurs any loss to the company his agreement will be cancelled or he will be penalized or his payment will be with held. At the circumstances of lorry, tempo or any other strike if the company is not able to procure the green's, farmers should themselves make arrangement to supply the greens to the factory. At that instance the company would bear the payment charges to the farmers incurred towards the transportation.
- 6. Farmer should not sell the greens produced to any other company or market without prior permission from the company. If done so the company has every right to cancel his agreement, purchase of greens will be stopped and his dues to the company will be recovered.
- Company shall provide high quality seeds to the farmers. Farmer should apply and spray the fertilizers, 7. fungicides and insecticides recommended and issued by the company. At any circumstances farmer should not spray any fungicides and insecticides not recommended / issued by the company. The input costs incurred will be deducted at the first installment. Farmers should submit the crop management record certifying that he has used the fungicides and insecticides recommended / issued by the company. After receiving the certificate only the payment will be made to the farmers.
- 8. Grading of greens will be done by company certified grading equipments and sieves only.
- 9. Even though company provides technical guidance through Agri team for getting good crop, farmers should put his potential to get highest yield. Also company will not give any assurance regarding lower yield, profit

and any other results against the crop. Farmer will bear the soul responsibility of loss or gain in the crop. Based on the crop status, diseased and other characters of the greens, terminating the greens purchase will be done by the company Agri team and farmers should abide to it.

- Payment will be made 30 days after supplying the greens and at every fortnight nearly 70 per cent will be paid 10. and final settlement will be made 30 days after handing over the pass book.
- Supply of greens should be of export quality and up to the specifications of the company. Company will not 11. purchase greens, which are non graded, insect damaged and any other defective ones. At that instance buying will be tentatively stopped and company will bring it to control and supportive to the farmers. The following defective gherkins will not be purchased. 1) Bent and crooked 2) Bleached 3) Fruit fly infested 4) Stalked 5) Flowered 6) Twins 7) Broken / Cut 8) Muddy / soiled 9) Fungus 10) Rotten 11) Junk materials 12) Ringed ones 13) Virus infected. Farmer should solely agree and abide to this agreement. Any mitigations or differences or problems encountered will be solved mutually. At times Arbitration and
