# **Duties and Responsibilities**

Under the overall supervision of the FAO Representative in Bangladesh, and the technical supervision of the NPC and LTO, in close consultation and cooperation with BARI of the Ministry of Agriculture (MOA), the incumbent will be responsible to provide the following services:

- Review socio-economic and agricultural baseline and identify current options of cropping system for the Project areas;
