Introduction

The project envisions safe food production and sustainable agriculture development through adoption of organic farming practices that are developed by testing and validating at Farmer Field School (FFS) . It assists in upscaling production, processing, certification and marketing of organic products.

The project is implemented by the Ministry of Land Management, Agriculture and Cooperatives (MoLMAC) with technical and financial support of Food and Agriculture Organization of the United Nations targeting smallholder farmers of Surkhet, Dailekh Jumla and Mugu districts of Karnali Province. The project capacitates agri value chain actors including farmers, government officials, collectors, processors and traders in promoting organic agriculture production and sustained income and livelihood.


