Tudor Rose and FAO are collaborating to publish a book for the International Year of Family Farming in 2014

This innovative co-publishing agreement has been formed to combine the professional publishing and marketing skills of Tudor Rose with the global knowledge, extensive intergovernmental setting and international development agenda of FAO.

It will enable both entities to advance their shared commitment to the importance of family farming as both agents and beneficiaries of improving food security and promoting sustainability. Tudor Rose has worked on previous publications for the United Nations, full details of these publications are included on the concluding pages of this document.

DEEP ROOTS will be a fully illustrated 300-page book with over 100 authors relating their work in family farming policy development and actions at international, regional, national, municipal and local levels of activity. Their commentaries will draw upon experiences around the world, reflecting how Governments, civil society and other stakeholders focus on family farming to achieve social development goals and advance the well-being of societies.

DEEP ROOTS will reflect the progress and challenges in these fields, highlighting good practices in a wide variety of countries and regions. By focusing on the experiences and livelihoods of people, especially those in vulnerable situations, the book will strive to project the benefits of focusing on family farming in overall development efforts. It will also emphasize how family-oriented policies

and programmes can contribute to achieving sustainable development goals.

This co-publication between Tudor Rose and FAO will amplify the international dialogue being conducted for the International Year of Family Farming in 2014 and beyond. This innovative endeavour is a striking example of sharing respective resources to engage governments, international and civil society organisations, academics and other shareholders in sharing their perspectives on family farming and displaying the extent and variety of their efforts to make the world a better place by focusing on family farming. The book will be available as a digital edition from September 2014, and a printed hardback book from October 2014.

THE INTERNATIONAL YEAR OF FAMILY FARMING



The 2014 International Year of Family Farming (IYFF) aims to raise the profile of family farming and smallholder farming by focusing world attention on its significant role in eradicating hunger and poverty, providing food security and nutrition, improving livelihoods, managing natural resources, protecting the environment, and achieving sustainable development, in particular in rural areas. The goal of the 2014 IYFF is to reposition family farming at the centre of agricultural, environmental and social policies in the national agendas by identifying gaps and opportunities to promote a shift towards a more equal and balanced development. The 2014 IYFF will promote broad discussion and cooperation at the national, regional and global levels to increase awareness and understanding of the challenges faced by smallholders and help identify efficient ways to support family farmers.

FOUR KEY OBJECTIVES OF THE INTERNATIONAL YEAR

- 1. Support the development of policies conducive to sustainable family farming by encouraging governments to establish the enabling environment (conducive policies, adequate legislation, participatory planning for a policy dialogue, investments) for the sustainable development of family farming.
- 2. Increase knowledge, communication and public awareness

- 3. Attain better understanding of family farming needs, potential and constraints and ensure technical support
- 4. Create synergies for sustainability

THREE GLOBAL LINES OF ACTION

The IYFF will focus on three global lines of action that will be implemented in the context of the national processes and agreements, in collaboration with relevant partners.

- 1. Promotion of dialogue in policy decision-making processes
- 2. Identification, documentation and sharing lessons learned and successful experiences of existing profamily farming policies at national and/or other levels to capitalize relevant knowledge on family farming
- 3. Communication, advocacy and outreach

Master Plan

A Master Plan has been drafted to outline the vision and objectives of the IYFF. This document is based around three key questions:
What is family farming?
Why is family farming important?
How can the IYFF safeguard, support and empower family and smallholder farmers?
