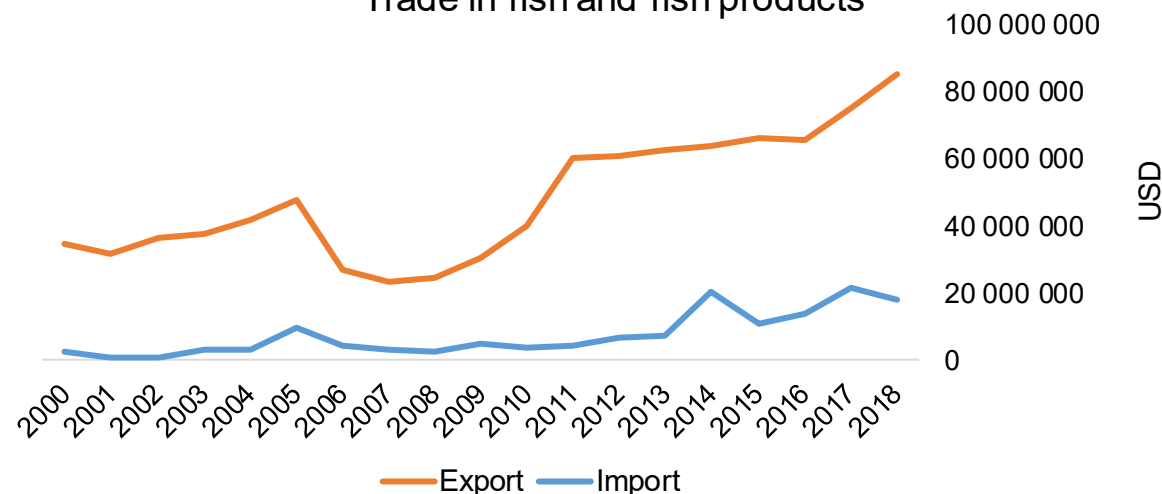

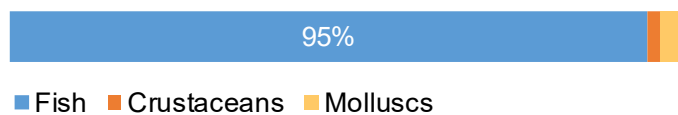

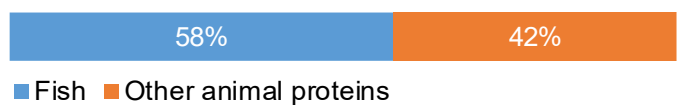
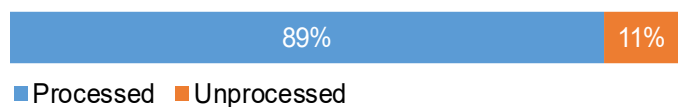

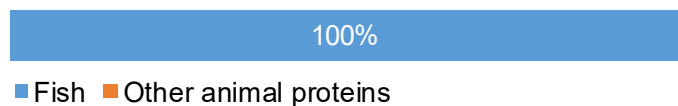
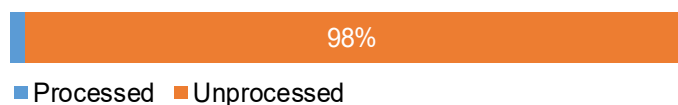
Production by volume
