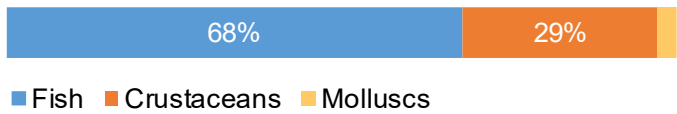

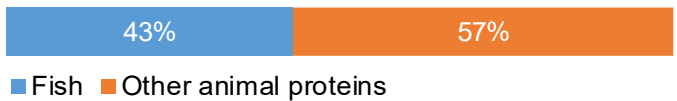

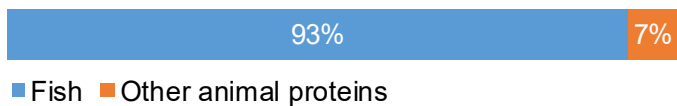
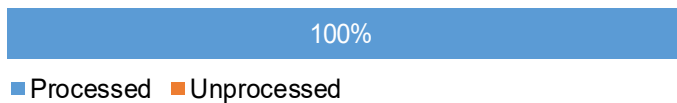
## Production by volume
