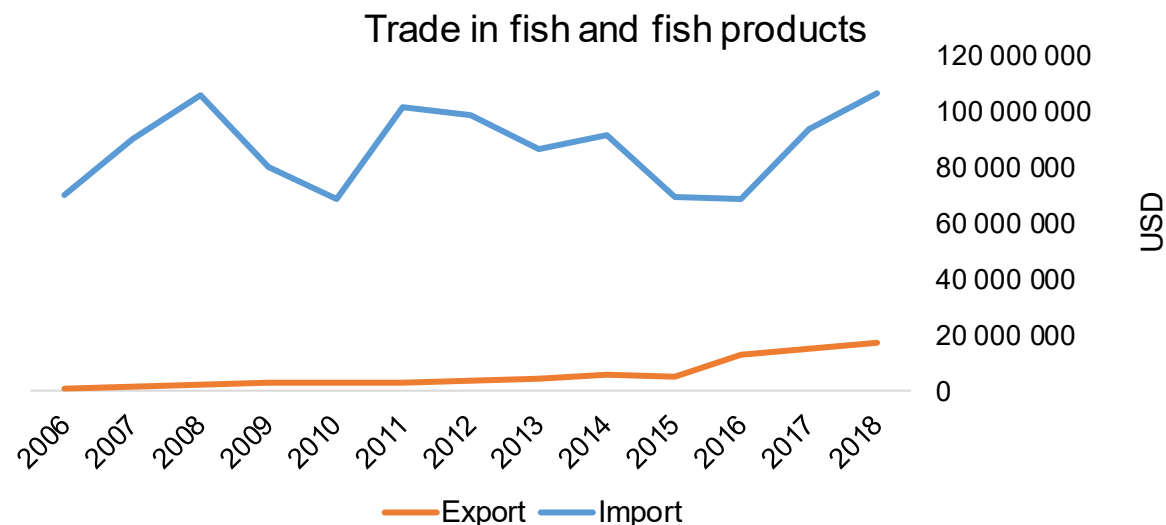

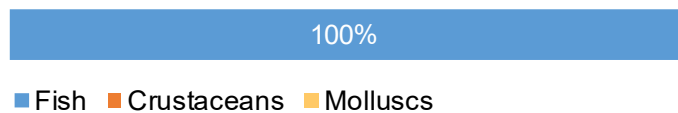

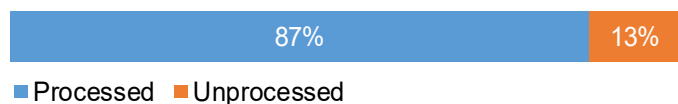
### Production by volume
