The strengthening of the project's design, containing clear objectives, sound performance indicators and the establishment of measurable targets, should be considered as the reference to construct this system. In particular, it is recommended that direct engagement is made with the World Bank initiatives in both countries to explore how the sustainability of processing and marketing initiatives established by the project can be strengthened through successful credit applications supported by the project. Helping Recommendation 7 to FAO on sustainability: <b>Developing closer and more functional partnerships with extension services.</b> It is recommended that during the proposed 14-month extension, a much closer and more practical partnership is developed between project staff and the municipal extension services. It is recognised that funds may need to be assigned to ensure this takes place. This is to ensure that the capacity of extension services is enhanced in all the techniques, procedures and initiatives being undertaken by the project in the interests of sustainability and institutionalization of the project's model. Recommendation 8 to FAO on up-scaling:  The development of thematic synthesis reports. It is recommended that a series of strategic thematic synthesis reports be developed over the next 14 months which provide overviews and assessments of key successes of the project, presented in a balanced and objective manner and supported by empirical evidence. These are considered an essential legacy of the project, and also a valuable tool for widening the impacts of the project's achievements. Examples include, but are not limited to, forage crop production for winter feeding of dairy cows; silage production; incentives for the formation and durability of livestock farmers' groups, etc.	Take-up the preparation of these reports during implementation of extension phase and indicate this task into the TORs of the consultants.
