Urban forestry innovations: Transforming landscapes for human well-being in the post- Covid-19 era

Zoom Webinar, 19-21 October 2020

Asia is home to more than 55% of the world's urban population, and is projected to experience the world fastest urban growth over the coming decades with two out of three inhabitants of the region living in cities by 2050. Depletion of natural resources, quality water scarcity, increased air pollution, and adverse climate change effects are among the main issues that Asian cities are facing as a consequence of this fast urbanization process. If well-managed, forests and trees in and around cities can provide a wide range of socio-economic and environmental ecosystem goods and services towards a more sustainable and resilient urban development. A number of countries in the Region are leading the way in the implementation of national and local programmes to promote urban forestry as a tool for sustainable and resilient urban development however, the potential of urban forests and trees is still far from being fully exploited.

The Food and Agriculture Organization of the UN, the Royal Forestry Department of the Government of Thailand are co-organizing an online event "Urban forestry innovations to transform landscapes and well-being in the post-Covid-19 era" that will be held from 19 to 21 October 2020, as part of the effort to promote and bridge towards the third Asia-Pacific Urban Forestry Meeting (APUFM), planned in February 2021.
