



INTERNATIONAL TREATY ON PLANT GENETIC RESOURCES FOR FOOD AND AGRICULTURE

HELPDESK WORKSHOP FOR THE PARTNERS OF THE FOURTH CALL FOR PROPOSALS OF THE BENEFIT-SHARING FUND

Rome, Italy, 22-26 October 2018

REPORT

1. INTRODUCTION

- 1. The Bureau of the Eighth Session of the Governing Body approved, in July 2018, a portfolio of 20 pre-proposals to be invited to develop full project proposals that will be funded in the Fourth Call for Proposals (CFP-4) of the Benefit-sharing Fund (BSF). The Bureau based its decision on the outcome of the work done by the Independent Panel of Experts and the methodology for the approval of project proposals that has been prepared by the Secretariat. The list of approved projects is available in Appendix 1 to this document.
- 2. According to the *Operational Procedures for the use of resources under the direct control of the Governing Body*, a Helpdesk was established to provide support, guidance and technical assistance to the BSF applicants throughout each Call for Proposals.
- 3. The Secretariat organized a one week Helpdesk Workshop from 22 to 26 October 2018 to support CFP-4 applicants in the development of their full project proposals. The workshop took place at FAO Headquarters in Rome. The list of participants is included in Appendix 2 to this document. The programme of the workshop is available in Appendix 3 to this document.
- 4. During the Helpdesk Workshop, for the first time since BSF has been established, 20 successful partners from around the world worked together under a programmatic approach to strengthen their full project proposals, and establish linkages between selected projects and across regions. The aim was to work in an inclusive, collaborative and participatory manner towards a collective understanding of the CFP-4 programme as to maximize impact beyond individual projects and contribute to the scaling up and sustainability of funded interventions.

2. HELPDESK WORKSHOP PROGRAMME


- 6. The CFP-4 will fund 20 projects¹, both single country and multi-country, that will be implemented around the world by National Research Institutes, Governments, NGOs, CGIARs and Universities.
- 7. The objective of the Helpdesk Workshop was to equip the participants with a common understanding on what is the CFP-4 programmatic approach, its linkages with the relevant Treaty mechanisms as well as to provide support, guidance and coaching to the successful applicants of the CFP-4 in the development of their full project proposals.
- 8. The programme of the Helpdesk Workshop tackled a wide range of topics related to agrobiodiversity: conservation and sustainable use of PGRFA, access and benefit-sharing, as well as cross cutting issues such as enabling policy environment, inclusiveness, gender mainstreaming and visibility.
- 9. During the workshop, representatives of the successful applicant institutions received guidance and explanation of the type and quality of the information that it is expected to be provided in the full proposals. The Secretariat undertook individual coaching to each participant on improvements to be done to the full project proposal, including through providing the feedback of the appraisal of the draft full project proposals carried out by the Independent Panel of Experts.
- 10. Many of the workshop participants had not been involved in the Treaty implementation in the past. The workshop provided an opportunity to train a new generation of PGRFA researchers and experts in the development and use of the main operational mechanisms of the Treaty, such as: Benefit-sharing Fund, the Multilateral System and its enhancement process, the Funding Strategy, Farmers' Rights and Global Information System.
- 11. The workshop was interactive and participatory, enabled discussion and exchange of information and knowledge among the participants, the Secretariat of the International Treaty, FAO officers and from donors to the Benefit-sharing Fund such as the Governments of Norway and Switzerland. The workshop created an enabling environment for BSF-4 participants to understand how their approved proposal would contribute to the realization of the CFP-4 programme. It created opportunities for networking and broadening of partnerships between representatives of 20 different institutions, as well as enabled synergies between and within different project proposals. Participants were grouped by regions and worked together as to get familiar with the type of activities that will be implemented in their respective regions and elaborated upon a regional Logical Framework. This exercise enabled the participants to review and further analyse the effectiveness and feasibility of their planned targets as well as further refine their respective methodologies and partnership arrangements.
- 12. The workshop took place in the form of presentations, group works, open discussions and individual coaching. Interpretation has been provided in English, French and Spanish. All presentations as well as the technical proposals have been made available to all the participants.
- 13. The workshop set the scene for further consultations within communities, governments and other PGRFA stakeholders. Lessons learnt and suggestions on how to further improve the workshop and how to better streamline its contents have also been received and recorded by the Secretariat.

3. COMPILATION OF THE RESULTS OF THE WORKSHOP EVALUATION






1. What is your overall assessment of the workshop?








4. FOLLOW UP ACTIVITIES

- 15. After the workshop, the CFP -4 partners have engaged in the development of their full project proposals as to incorporate the guidelines and the training received during the meeting. The deadline for the submission of the full project proposals was 30 November 2018. To date, all the full project proposals, including the relevant Annexes, have been received and filed by the Secretariat. In addition, the Secretariat has shared the final full project proposals with the members of the Independent Panel of Experts.
- 16. The Secretariat has prepared draft contractual agreements (Letters of Agreement) to be shared with the CFP -4 partners for comments and has started preparing all the necessary documentation to enable the Quality Assurance and Clearance process by the FAO Contracts Unit. Considering that the CFP- 4 projects are highly dependent on the seasonality of field activities, the Secretariat has grouped the approved projects in 3 batches. The preparation and clearance of project agreements will follow these batches, with top priority contracts already being prepared and signed. This will enable partners to follow their workplans and be able to deliver the planned targets within the established timeframe. Upon the signature of the contracts with CFP- 4 partners, first disbursements will be processed and projects will start their implementation.
- 17. The workshop has been an excellent opportunity to share views, ideas, and experiences among a wide range of stakeholders. The Secretariat will incorporate lessons learnt from the workshop and will build upon the ideas and concepts that have emerged during the meeting in preparing the BSF workplan, in the further development of the programmatic approach of the BSF and the on-going review of the Funding Strategy. Further work will be undertaken by both, CFP-4 partners and the Secretariat, as well as other relevant constituencies to:
 - develop the aggregated Logical framework of the CFP 4 programme;
 - continue to support partners in mainstreaming the gender dimension in project activities;
 - develop and share with BSF partners a communication toolkit to further enhance the visibility of the CFP 4 portfolio as to better communicate impact, results and best practices, in line with the recommendations of the Independent Evaluation of the second project cycle portfolio and the recommendations of the European Commission's *Results Oriented Monitoring* mission for BSF;

- individuate and build synergies and complementarities between BSF funded projects (both ongoing CFP 3 and CFP 4);
- enhance efforts to mobilize resources for the projects that obtained a certificate of excellence from the independent Panel of Experts;
- link the CFP 4 programme to broader initiatives and programmes on agrobiodiversity and implementation of Treaty provisions as such;
- organize a midterm workshop to bring together BSF partners (both BSF 3 and BSF 4) along with relevant PGRFA practitioners to share experiences, achievements, methodologies, successful models and best practices and further elaborate on the BSF programmatic approach.
- 18. In addition, the Secretariat will develop a web tool/platform for bringing together all CFP-4 partners as well as BSF constituencies to better communicate results, good practices and lessons learnt from the implementation of BSF projects and implementation of the International Treaty. This web tool will facilitate exchange of information between CFP -4 partners and PGRFA stakeholders, will enable the sharing knowledge and success stories and contribute towards the establishment of a community of good practices. It will also contribute towards building synergies and complementarities between projects and across regions.
