REPORT OF THE JOINT MEETING OF THE HUNDRED AND EIGHTEENTH SESSION OF THE PROGRAMME COMMITTEE AND HUNDRED AND SIXITIETH SESSION OF THE FINANCE COMMITTEE

Rome, 4 November 2015

INTRODUCTION

1. The Joint Meeting submitted its Report to the Council.

2. In addition to the Chairperson, His Excellency Serge Tomasi (France), and Mr Khalid Mehboob (Pakistan), Chairperson of the Finance Committee, the following representatives of Members were present:

Introduction

3. The Joint Meeting welcomed the engagement by the Director-General with Members of the Joint Meeting.

Adjustments to the Programme of Work and Budget 2016-17¹

4. Having considered the separate deliberations of the Programme and Finance Committees on the adjustments to the Programme of Work and Budget 2016-17, and noting the spirit of cooperation among Members and with the Secretariat, the Joint Meeting:

- a) welcomed the document reflecting the decisions of the Conference;
- b) <u>expressed satisfaction</u> that the required budgetary savings of USD 2.7 million would be achieved through reductions in staff costs, noting that the Finance Committee would receive further information on measures to achieve the savings during the biennium;
- welcomed the alignment of FAO's Strategic Framework with Sustainable Development Goals (SDGs), and noted there would be opportunity for bringing further coherence during 2016 in preparing the Medium Term Plan 2018-21;
- d) <u>welcomed</u> the updated results framework, and supported the introduction of climate change as a cross-cutting theme under Objective 6;

- e) <u>emphasized</u> the importance of strengthening the Technical Cooperation Programme (TCP), and welcomed the USD 2 million mobilized so far toward the SIDS² Trust Fund, and <u>encouraged</u> more voluntary contributions from Members and resource partners;
- f) welcomed the additional clarifications and noted with appreciation the emphasis on enhanced programme delivery through internal management arrangements, including the establishment of Strategic Programme leaders and teams; and
- g) <u>encouraged</u> the Secretariat to continue consolidation of decentralization efforts, and enhancing capacity and internal control at decentralized locations, while maintaining the technical capacity at headquarters to achieve the programme of work.

Independent review of decentralized offices network³

- 5. The Joint Meeting:
 - a) <u>recommended</u> the Council to consider the review paper as a response to a Conference request following the five individual evaluations of FAO's regional and subregional offices, and noted the independent validation of the document carried out in each region;
 - b) <u>appreciated</u> the fact that the document provided comprehensive and sound technical analysis based on objective and relevant data on FAO's decentralized offices;
 - c) <u>recognized</u> the need to update the historic legacy of coverage of FAO offices in decentralized locations, in order to meet shifting global realities and trends so as to deliver more effectively against Strategic Objectives;
 - d) <u>supported</u> in principle a budget neutral approach to any potential adjustments to country coverage;
 - e) <u>welcomed</u> the proposed principles and criteria contained in the document and <u>underlined</u> the need for a tailored approach on a case-by-case basis in reviewing the findings and recommendations contained in the document;
 - f) with regards to regional and subregional offices, <u>stressed</u> the need to take into account the criteria outlined in the report; and
 - g) <u>recommended</u> the Council transmit the document for review to the 2016 Regional Conferences, and thereafter re-examine the coverage of FAO's decentralized offices at its session in June 2016.
- 6. Concomitantly, the Joint Meeting:
 - a) <u>encouraged</u> the Secretariat to continue consolidation of decentralization efforts, and enhancing capacity and internal control at decentralized locations, while maintaining the technical capacity at headquarters to achieve the programme of work; and
 - b) <u>looked forward</u> to the outcome of analysis of skills gaps at headquarters and in decentralized locations for enhanced programme delivery.

- 7. The Joint Meeting welcomed these progress reports, and:
 - a) <u>commended</u> the Secretariat on finalizing 40 new agreements with the private sector and with civil society organizations since its last report in November 2014;
 - b) <u>recalled</u> the importance of partnerships in supporting the Strategic Objectives, building bridges and increasing FAO's visibility;
 - c) <u>appreciated</u> that partnerships contribute to one or more Strategic Objectives of the Organization;
 - d) <u>appreciated</u> the due diligence process carried out in assessing risks and maintaining neutrality in approaching partners;
 - e) <u>encouraged</u> the Organization to further engage in partnerships contributing to FAO's work on climate change;
 - f) stressed the importance of gender considerations in partnership work;
 - g) <u>highlighted</u> the importance of regional balance in forging partnerships;
 - h) welcomed the work on fostering application and dissemination of Voluntary Guidelines on the Responsible Governance of Tenure of Land, Fisheries and Forests in the Context of National Food Security (VGGT); Voluntary Guidelines to Support the Progressive Realization of the Right to Adequate Food; the Principles for Responsible Investment in Agriculture and Food Systems (RAI), the Voluntary Guidelines for Securing Sustainable Small-Scale Fisheries (SSF) in the Context of Food Security and Poverty Eradication; and the Framework for Action for Food Security and Nutrition in Protracted Crises (CFS-FFA); and
 - i) <u>looked forward</u> to continued annual progress reports, including information on the diversity and geographic distribution of partnerships.

Any other business

8. The Joint Meeting reiterated that the proper functioning of the governing bodies is impeded by the late submission of documents and requested the Secretariat to comply with standing guidance to ensure the timely submission of documents at least two weeks in advance in all official languages of the Organization in the future.
