<p style="text-align: center;">Canada (Mon 24/05/2021 11:04 PM)</p>	<p>Canada commends the work of FAO for the 2018-19 Biennium and underlines its contribution to the achievement of the Sustainable Development Goals (SDGs). We congratulate FAO on the achievement of the majority of its targets, as measured by the indicators, but also acknowledge the important work ahead during the Decade of Action for Agenda 2030. Canada encourages FAO to continue to develop clearer linkages between its strategic policies, its activities and the SDGs. This Report should inform the operationalization of the new Strategic Framework 2022-31 as there is a need to further underscore the importance of women, youth and Indigenous peoples, in particular rural and Indigenous women, in FAO's activities. As part of Strategic Objective 1: "Contribute to the eradication of hunger, food insecurity and malnutrition", Canada greatly appreciates FAO's contributions to the establishment of a thematic work stream within the Committee on World Food Security (CFS) on gender equality and women's empowerment. We further underline the importance of mainstreaming gender as a cross-cutting issue across all objectives. Canada commends FAO for its critical work towards the achievement of Strategic Objective 2: "Make agriculture, forestry and fisheries more productive and sustainable." The results of its activities notably include FAO support in piloting and scaling-up innovative approaches to sustainable agricultural production such as the application of biotechnologies. Canada is pleased with the implementation and the outcomes of Strategic Objective 4: "Enable more inclusive and efficient agricultural and food systems" as it has greatly contributed to food security by increasing access to international markets which improves access to food. We also underline FAO's standard-setting work, including on Maximum Residue Limits, as another important outcome of the activities under Strategic Objective 4. Canada notes that the delivery of Governing Body documents according to deadlines and language requirements under key performance indicator 10.1.A of Functional Objective 10: "FAO Governance, oversight and direction" was not</p>

<p>The United States of America (Tue 5/25/2021 12:18 AM)</p>	<p>The United States applauds FAO for its work over the last biennium.</p> <p>We encourage FAO to continue its fight against hunger, food insecurity and malnutrition, especially as progress has stalled and reversed throughout the world due to the COVID-19 pandemic. Recovery from the pandemic and preparedness for evolving threats is urgently needed.</p> <p>We recognize the strong role that FAO plays in leading countries towards more sustainable agricultural production, and we encourage FAO to ensure farmers have knowledge and access to all the tools to increase production while reducing inputs and increasing sustainability in its three dimensions.</p> <p>Ensuring farmers have access to appropriate, science-backed technologies is equally important in the fight against pests such as Fall Armyworm and Desert Locust.</p> <p>We also encourage FAO to continue working to address Antimicrobial Resistance (AMR) and zoonotic diseases through the One Health approach, firmly based on science and with input and open consultations with Members, the One Health Tripartite and United Nations Environment Programme (UNEP) and other relevant international organizations.</p> <p>We are pleased to see a more prominent role for FAO's normative work.</p>
<p>European Union (Thu 27/05/2021 4:51 PM)</p>	<p>The European Union and its 27 Member States would like to express our satisfaction with the fact that FAO has accomplished 95 percent of the 2018-2019 Programme of Work and Budget outputs. We also commend FAO with the achievement of USD 11.7 million in efficiency savings in the biennium.</p> <p>We welcome FAO's contribution to eradicating hunger, food insecurity and malnutrition, despite the slow increase in the number of people in food insecurity even prior to the COVID-19 pandemic.
