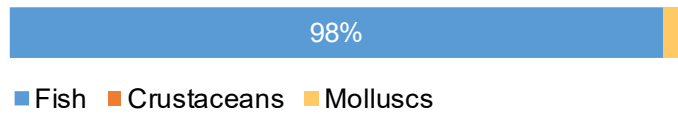

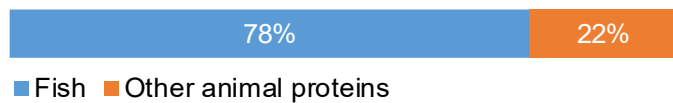
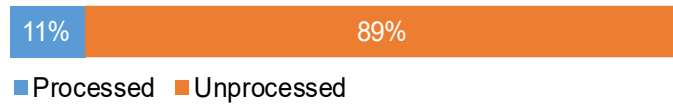

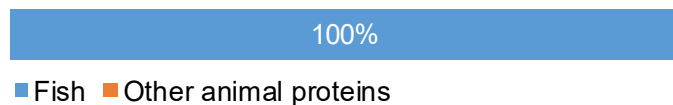
Production by volume

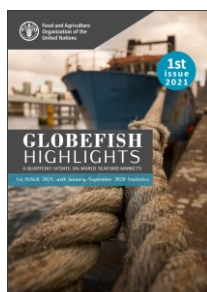

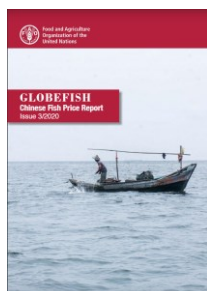
