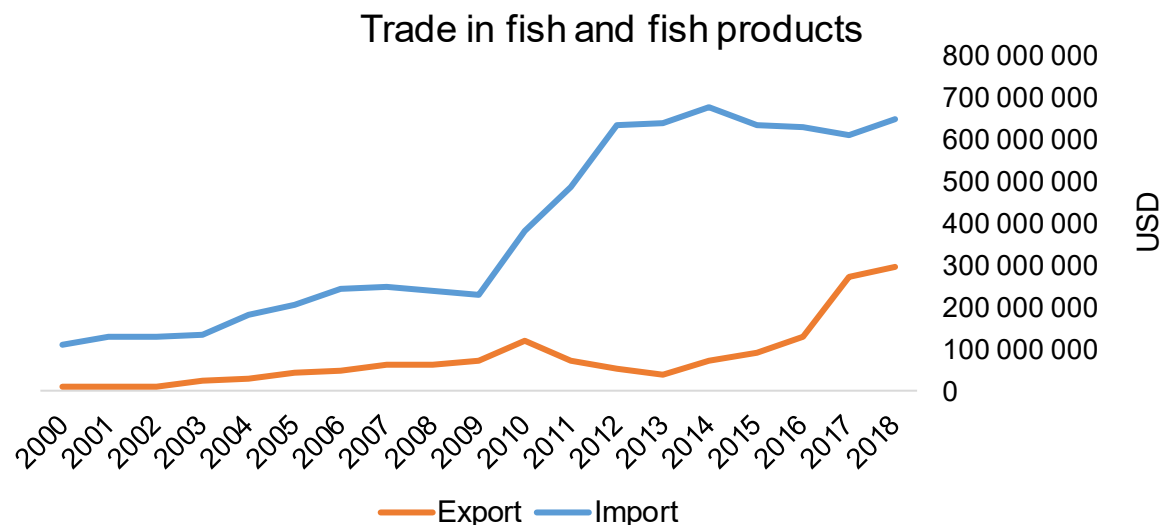

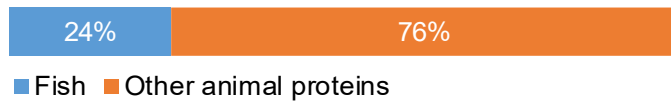

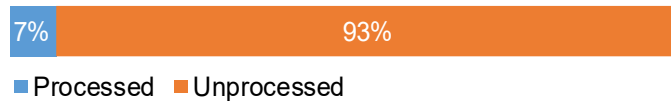
Production by volume

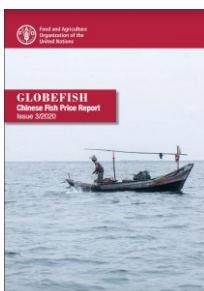
