# INTRODUCTION

Only with knowledge can we free the world from hunger, malnutrition and poverty. According to the Basic Texts of the Food and Agriculture Organization of the United Nations (FAO), the Organization's first function is to "collect, analyse, interpret and disseminate information relating to nutrition, food and agriculture". FAO's strategic focus on "the four betters" – better production, better nutrition, a better environment, and a better life – provide the roadmap guiding this work, within the broader perspective of the Sustainable Development Goals (SDGs) agreed by the United Nations and the international community as part of the 2030 agenda.

FAO plays a unique role as a neutral forum, providing unbiased, high-quality information across all areas relating to food, agriculture and sustainable natural resources management. In 2021, FAO issued over 900 publications, ranging from authoritative analysis for policy makers and expert guidance for farmers to general knowledge for young people. Of these, an increasing number are now available in device-friendly formats. This catalogue includes a selection of the Organization's most recent titles, as well as some older publications that have become references in their respective fields. In addition to English, numerous reports are available in Arabic, Chinese, French, Russian and Spanish.

The 2020 edition of The State of World Fisheries and Aquaculture marks the 25th anniversary of the Code of Conduct for Responsible Fisheries (the Code) and the maturation of several Sustainable Development Goal indicators. It also closely follows an International Symposium on Fisheries Sustainability, hosted by FAO, and the finalization of FAO guidelines on sustainable aquaculture growth and social sustainability along value chains. While Part 1 retains the format of previous editions, the structure of the rest of the publication has been revised. Part 2 opens with a section on the Code and focuses on issues related

to Sustainable Development Goal 14 and its indicators for which FAO is the custodian agency. The topics discussed range from data and information systems to ocean pollution, product legality, user rights and climate change adaptation.
