#### **OPENING REMARKS FROM PROPAC PRESIDENT**

Your Excellency Francisca Eneme Efua, Minister of Agriculture, Livestock, Forestry and Environment of the Republic of Equatorial Guinea and President of the 32nd FAO Africa Regional Conference,

For a larger participation of CSOs, the consultation of CSOs which has become a tradition is held on the sidelines of regional conferences and focuses on the same agenda as the conferences themselves. However, for this year, the context of the covid-19 crisis has made things a little more complicated, making it impossible to hold in person.
