# Minutes of the 6<sup>th</sup> Meeting of the Working Group on the Proposal of the Establishment of the Sub-Committee on Fisheries Management (WG 6)

Discussion:

#### 1. Adoption of the Agenda

The Chairperson opened the meeting by mentioning that this was the last meeting of the WG. The draft Provisional Agenda was adopted without any change as attached in **Appendix 2**.

### 2. Formulation of a proposal to COFI 35

- (1) The Chairperson introduced WG 6/1 (Draft Proposal to COFI 35 on the Establishment of the Sub-Committee on Fisheries Management)<sup>1</sup>.
- (2) With regard to the table in Paragraph 2 (2) of the main text, the Representative of European Union inquired if we could have all three Sub-Committees in hybrid mode or in person once all conditions are met. The Chairperson replied that two out of three Sub-Committees will be in person, but one of them must be in virtual modality because of the burden for developing countries, even if all conditions are met. The Representative of Indonesia confirmed its intention to host the 14<sup>th</sup> Session of the Sub-Committee on Aquaculture (SCA) in 2027. The Chairperson proposed to change SCA in 2027 (Between COFI 37 and 38) from "virtual" to "in person" and the Sub-Committee on Fisheries Management (SCFM) in 2027 from "inperson" to "virtual".

The Representative of Australia underscored the importance of the review process since there has been no agreement on Options yet. The Representative of Cook Islands also expressed the concern about the difficulty for a smaller administration and proposed to establish SCFM in a trial basis or introduce a review process. The Representative of the United States of America mentioned that the review should be conducted in a longer horizon rather than by COFI 36. The Representative of Norway echoed the longer period before the review, e.g., after 2-3 meetings of SCFM. The Representative of Canada also mentioned that it could be too short after two meetings of SCFM and proposed five year operation before the first review. The Representative of the United Kingdom and the Representative of the European Union also supported the longer-term review process. In particular, the Representative of the European Union noted that the new sub-committee is established to improve COFI

efficiency. Its success in achieving this objective can only be assessed after a few COFI meetings. Therefore, to be relevant, the review should be carried out after several COFI meetings. He also proposed that the review should include the review of how the discussion at the SCFM meetings improved efficiency of COFI. The Representative of Canada supported it. The Chairperson proposed that COFI 38 will review the results of the three session of SCFM, including how the SCFM functioned and contributed to COFI 36 and 37, and consider whether SCFM should continue to be held.

With regard to the tables of Appendix 4 and its Attachment, the Chairperson proposed the ones including Members and observers which participated in any of COFI 32, 33 and 34, as attached in **Appendix 3** in order to accommodate the concern expressed by the Representatives of the Southwest Pacific Region. It was agreed to include further participation in the last three sessions of the Sub-Committee on Fish Trade as well into consideration.

With regard to the supporting fund, the Representative of Malaysia proposed to select Members who will receive the support based on a rotation basis in each Regional Group. The Chairperson referred to Paragraph 2 of Appendix 4 and replied that the decision should be made by each Regional Group. The Representative of Argentina supported the Chairperson. The Representative of Indonesia expressed a concern about the reference to "other donors, including companies, stakeholder groups, and NGOs" in Paragraph 2 (9) of the main text. The Representative of Argentina also expressed a concern about the reference to "and other donors" in Paragraph 2 of Appendix 4 and underscored that the fund should be allocated without condition. It was then agreed to insert "no earmarked" before "financial contributions" in Paragraph 2 (9) of the main text as well as delete "and other donors" from Paragraph 2 of Appendix 4.

With regard to Appendix 3, the Representative of the United States of America proposed to change "at least two weeks" to "at least four weeks" before the meeting in Paragraph 2 as well as expressed that this consideration on the administrative difficulty should be applied not only for SCFM but also other two Sub-Committees. The Representative of the United Kingdom appreciated the change from "two" to "four" weeks and further pointed out that the time conflict could happen other meetings beyond fisheries.

#### 3. Identification of any further work

It was agreed that the Chairperson would circulate the revised draft proposal to the registered participants for their final confirmation.

#### 4. Any other matters

No other matter was proposed to be discussed.
