## Information for participants of the 28th Session of the Committee on Agriculture

### Time and venue

The 28th Session of the Committee on Agriculture (COAG 28) will be held in a hybrid meeting modality, comprising participation both in-person at FAO headquarters and through the Zoom videoconferencing platform.

The connection details for accessing the Zoom platform has been sent to all registered participants. COAG 28 meetings are scheduled from 18 to 22 July 2022. Meetings will take place from 9.30 h to 12.00 h in the morning, from 14.00 h to 16.30 h in the afternoon, and from 17.00 h to 19.30 h in the evening (CEST - UTC +2).

COAG 28 meetings will take place in the Plenary Hall located on the third floor of Building A, where up to two representatives per Member of the Committee may attend in-person.

Additional delegates of Members as well as representatives of the Observers of the Committee may attend the meetings in the Green Room located on the first floor of Building A.

Side events will be held in the Sheikh Zayed Centre.

### Accessing FAO headquarters

Participants may enter FAO headquarters from the main gate in Viale delle Terme di Caracalla.

FAO permanent building passes are sufficient to access FAO headquarters and attend the COAG.

Building passes to access FAO headquarters may be collected at the reception desk located at the FAO Main Entrance (Visitors gate).

Participants may then enter the FAO building through the main entrance in Building A. While inside the premises, participants are required to use FFP2/N95 masks or equivalent during meetings.
