



# **Committee on Forestry**

### Mandate:

- periodic reviews of forestry problems of an international character
- review the programmes of work of the FAO on forestry
  advise the Director-General on the future programmes of work on forestry

(Basic Text, Rule XXXI)

### Items arising from COFO 26 recommendations

### Agriculture and forestry linkages (item to be presented to COFO 27 and to COAG 29)

- recommended FAO to continue collecting and analysing necessary science- and evidence-based data on agriculture and forestry interdependencies, including on the direct and underlying drivers of deforestation and land degradation, by further enhancing consistency between agricultural and forest data sets, and compiling case studies and good practices which should be reported at COFO 27.
- a global assessment of the status and scaling-up potential of agroforestry, including agroecological principles and practices and other innovative approaches, to update the Global Forest Resources Assessment (FRA) categories covering production systems integrating trees and forests, and to report on progress to COFO 27

#### FAO Strategy on Climate Change 2022-2031

- called on FAO to provide regular updates to the Governing Bodies on the implementation of the FAO Strategy on Climate Change 2022-2031 through its Action Plan.
- FAO biennial Theme for 2024-25 Water resources management for the four betters: better production, better nutrition, a better environment and a better life, to achieve Agenda 2030 and the Sustainable Development Goals"

# New emerging items relevant to the mandate of COFO



### **Regional Forestry Commissions** (statutory bodies art .VI.)

- Provide inputs from the regions to COFO agenda
- Chairpersons of the RFCs act as members of the COFO Steering Committee (Vice-chairs of COFO)
- Report to the Regional Conferences
- Identify regional priorities for FAO's work in forestry



### **Recommendations to COFO 27 agenda**

#### The Latin American and the Near East Regions

#### FCLAC33:

- Sustainable forestry management and restoration
- Bioeconomy and value chains
- Forests and agrifood systems
- Forest financing
- Integrated fire management.

#### NERFC26:

- Agriculture and forestry linkages (forest and rangeland resilience, restoring silvopastoral systems, drought management)
- Sustainable wood production and planted forests in drylands.





### **Lessons learned from COFO26**

(based on feedback received through the COFO 26 survey and interviews)

- 1. Assuring a more focused substantive agenda and time for debate in plenary
- 2. Prioritize items for discussion with guidance sought from the Committee
- 3. The Written Correspondence Procedure (WCP)

8th Informal Regional Conference for North America


### 2-4 April 2024

- RFCs "to have a more policy-relevant role in the FAO Regional Conferences, and invited FAO to support further integration of important regional forestrelated matters"
- Bringing forest issues to the focus of regional policy dialogues.
