THE WORKPLAN AND MEETING SCHEDULE OF THE EXECUTIVE COMITTEE OF THE ECA FOR THE YEARS 2023-2025

Introduction

The ECA Executive Committee (ExCom) is the operational body of the European Commission on Agriculture (ECA). The Committee meets 4–5 times a year, either virtually or with physical presence.

The work of the Committee follows the work plan developed by the Secretariat of the ECA and endorsed by the Committee at the beginning of the term. The plan covers the period between the sessions of the ECA and includes the list of tasks for the Committee and the schedule of its meetings.

The draft list of tasks of the ExCom and their respective timeframes in the years 2023-2025 is presented in Annex 1.

The draft schedule of meetings of the Committee for 2024-25, until the Forty-fourth Session of the ECA, is presented in Annex 2.

The schedule assumes that the Forty-fourth Session of the ECA will be held as tentatively planned, i.e. between 30 September and 3 October 2025.

The ExCom is invited to:

- review and endorse the list of tasks of the ExCom for 2024-25 and their respective timeframes, as presented in Annex 1
- review and endorse the schedule and scopes of the ExCom meetings for the years 2024-25, as presented in Annex 2
- note that specific topics for updates under the task "Review of and recommendations on REU's work in Europe and Central Asia in 2024-2025 in selected technical areas" will be identified by June 2024
- note that the ExCom may decide to add more tasks or to modify the schedule and scopes of the meetings according to the needs.
