Changes in Representation of Members of the Finance Committee:  
Summary of the Qualifications of Mr Michael P. Glover  
(United States of America)

1. Rule XXVII-4(a) of the General Rules of the Organization (GRO) states: "If the representative of a Member of the Committee is expected to be unable to attend a session of the Committee, or if, due to incapacity, death or any other reason, he is prevented from exercising his functions for the remainder of the term for which the Member he represents has been elected, that Member shall inform the Director-General and the Chairperson as soon as possible, and may designate a substitute representative who shall have the qualifications and experience referred to in paragraph 1 of this Rule. The Council shall be informed of the qualifications and experience of the substitute representative".

2. Further to the details of changes in representation of members of the Finance Committee set out in paragraph 3 of document CL 137/9, a summary of the qualifications of Mr Michael P. Glover (United States of America) is given below for the information of the Council.

## UNITED STATES OF AMERICA

Name: Mr Michael P. Glover

Present Position: Deputy Permanent Representative at the U.S. Mission to the UN Agencies in Rome (since August 2009).

Main previous positions:

Mr. Glover entered the State Department as a PhD candidate in international economics and business at the University of Texas, and also holds a Masters Degree in history. He is the author of a book on Middle Eastern economic policy as well as various articles on international economics.

He holds the rank of Minister Counselor in the the U.S. Department of State, and previously served as Principal Officer at the U.S. Consulate General in Guayaquil, Ecuador and as an Economic Officer at American Embassies in London, Paris, Quito and Mexico City, as well as at the U.S. Mission to the Organization for Economic Cooperation and Development (OECD) in Paris and the U.S. Consulate General in Guadalajara, Mexico.

His Washington assignments include several positions in the Bureau of Economic, Energy and Business Affairs, including that of Deputy Special Representative for Commercial and Business Affairs, where he coordinated the State Department's global support for the U.S. business community and promoted corporate social responsibility abroad. As Director of the State Department's Office of Environmental Policy, he managed the United States' participation in a wide range of multilateral environmental agreements.

Participation in meetings or activities of the United Nations and its Specialized Agencies:

Immediately prior to his current assignment in Rome, he served as Director of the Office of Technical and Specialized Agencies in the Bureau of International Organization Affairs, which is responsible for developing United States positions on all foreign policy and institutional issues in over 30 multilateral organizations, including a number of United Nations Specialized Agencies.
