### Membership of the WFP Executive Board

#### Suggested Action by the Council

In accordance with FAO Conference Resolution 7/2011, the Council is required to elect six FAO Member Nations to the WFP Executive Board for a term of office of three years (1 January 2015 - 31 December 2017) to fill the following seats:

- 1 seat from List A
- 1 seat from List B (rotating seat for the period 2015-2017).
- 1 seat from List C
- 2 seats from List D
- 1 seat from List E

The attached nomination form should be completed by Member Nations wishing to stand for the above seats and submitted to the Secretary-General of the Conference and Council (Room A-139) by **12.00 hours on Monday, 24 November 2014.**

1. For purposes of election to the Board, FAO Member Nations are divided into five separate lists (A, B, C, D and E) as shown on the FAO Council Web page under "Additional Information": <http://www.fao.org/bodies/council/cl150/en/>
2. The Council is required to elect six members for a term of office expiring on 31 December 2017 to replace the ones whose term ends on 31 December 2014, i.e. Australia (List D), Brazil (List C), Ghana (List A), Luxembourg (List D), Slovakia (List E) and Tunisia (List A). It should be noted that the Floating Seat occupied by List A for the period 2012-2014 will pass to List B for the period 2015-2017.
3. Outgoing members are eligible for re-election.
4. A nomination form is given in *Appendix A*.
