### **Arrangements for the 43rd Session of the Conference (1-7 July 2023)**

#### **Executive summary**

This document contains the Tentative Timetable for the 43rd Session of the Conference, lists the Officers of the Conference for which candidates need to be nominated, and provides information on the Round Tables that are scheduled to take place during the week of the Conference.

#### Suggested action by the Council

- a) Endorse the Tentative Timetable for the 43rd Session of the Conference set out in Appendix A;
- b) Propose candidates for the following Officers of the Conference:
  - Chairperson of the Conference
  - Chairperson of Commission I;
  - Chairperson of Commission II;
  - Three Vice-Chairpersons of the Conference;
  - Seven elected Members of the General Committee; and
  - Nine Members of the Credentials Committee; and
- Take note of Round Table discussions to place during the Plenary sessions of the 43rd Session of the Conference.

#### I. Introduction

1. As decided by the 42nd Session of the Conference (14-18 June 2021), the 43rd Session of the Conference will be held in Rome from Saturday 1 to Friday 7 July 2023. The Provisional Agenda for the Session was approved by the 171st Session of Council (5-9 December 2022).

2. This document complements the arrangements for the 43rd Session of the FAO Conference approved by the Council at its 171st Session, which are contained in C 2023/12, including the proposal that the topic for the General Debate of the Conference under item 10 "Review of the State of Food and Agriculture" be "Water resources management for the four betters: better production, better nutrition, better environment and better life, to achieve Agenda 2030 and the Sustainable Development Goals".

#### **II.** Tentative Timetable

- 3. The Tentative Timetable for the Conference (*Appendix A*) is submitted for consideration by the Council, and subsequent submission to the Conference for approval.
- 4. The General Committee of the Conference shall review the Tentative Timetable at its first meeting to be held on the first day of Conference, and make a recommendation to the Conference for its approval (Rule X.2(a-b) of the General Rules of the Organization (GRO)), it being understood that the appointment of the Director-General shall begin and be effected within three working days following the opening date of the session (Rule XXXVII.1(d) of the GRO).
- 5. As set out in document CL 172/12/Rev.1, *Address by Candidates for the post of Director-General*, and in line with provisions of the relevant GROs, the appointment of the Director-General by secret ballot vote is scheduled to take place on Sunday 2 July 2023. This is consistent with past practice, including at the 41st Session (June 2019), the 37th Session (June-July 2011) and the 33rd Session (November 2005), when secret ballot votes for appointment of the Director-General were held on the first Sunday of the Conference week.
- 6. The address by the sole candidate for the post of Director-General at the Conference has been scheduled on Saturday 1 July 2023 in the afternoon, subject to approval by the Conference.

#### **III.** Officers of the Conference

- 7. In keeping with the practice of regional rotation, the FAO North America Regional Group is expected to submit to the 172nd Session of the Council the name of a representative of the North America Region as Chairperson of the Conference. Furthermore, the Council is invited to take into consideration the established practice of regional rotation regarding the chairpersonship of the Commissions whereby, in this instance, the Chairperson of Commission I would be from a country that is not a member of the G77 and China, and the Chairperson of Commission II would be from a country belonging to the G77 and China.
- 8. In accordance with Rule XXIV-5(b) of the General Rules of the Organization, the Council is requested to nominate candidates for the following positions:
  - i. Chairperson of the Conference
  - ii. Chairperson of Commission I;
  - iii. Chairperson of Commission II;
  - iv. Three Vice-Chairpersons of the Conference;
  - v. Seven elected Members of the General Committee; and
  - vi. Nine members of the Credentials Committee.
- 9. Following past practice, the nominated members of the Credentials Committee will commence their work in the 15 days leading up to the Conference.
- 10. Additionally, in line with the recommendation of the 165th Session of the Council and the approval by the 42nd Session of the Conference, the nominated Members of the General Committee

may meet informally ahead of the opening of the Conference session in order to undertake preparatory work, noting that such work would not constitute formal decisions of the Committee until its membership is elected by the Conference.

#### IV. Round Tables

- 11. In accordance with the decision of the 165th Session of the Council,<sup>2</sup> Round Table discussions are envisaged to take place at the 43rd Session of the Conference to foster interaction and dialogue among senior level officials in attendance.
- 12. The focus of the Round Table discussions will be on the General Debate topic and on matters related to the mandate of the Organization. Accordingly, panellists will be guided by a moderator and invited to take part in discussions, including in relation to *Water Resources Management for the four betters: better production, better nutrition, better environment and better life, to achieve Agenda 2030 and the Sustainable Development Goals.*
- 13. Three Round Tables are scheduled to take place in the Plenary session, in conjunction with the General Debate under item 10 of the Provisional Agenda.
