- 1. Opening of the Meeting.
 - The Chairperson will open the meeting, recalling that this meeting is convened in accordance with the Rules of Procedure (ROP) adopted by the Parties to the Agreement, and attended by the Parties and observers defined in Rule 8 of the ROP.
 - The Chairperson will provide information on the consultations held with the Secretariat and Vice Chairpersons during the intersessional period on the organization of the meeting.

 - The Chairperson will set out the arrangements for conducting the meeting, and remind delegates that meeting sessions will be conducted in accordance with the schedule provided, that delegates (both in presence and online) must raise their hand if they wish to take the floor, that the order for interventions will be first Parties, then non-party FAO Members, followed by other observers, and that all interventions will need to be limited to a maximum of three minutes.
