## Addendum 2

In accordance with Rule XXXVII, paragraph (1)(b) of the General Rules of the Organization 1. (GRO), the Council at its 170th Session "set the dates of 1 December 2022 to 28 February 2023 as the period during which Member Nations could submit nominations for the office of Director-General" (CL 170/REP, paragraph 35). It was also agreed by the Council that nominations received by the established deadline would be circulated one week thereafter by circular letter.

2. On 6 March 2023, the Secretary-General of the Conference and Council received a communication from the Government of the Republic of Iraq informing of the withdrawal of the nomination of Hamid Khalaf Ahmed.
