Report of the Credentials Committee

- 1. The Credentials Committee of the 43rd Session of the Conference held four meetings to examine the credentials received on 23, 27 and 30 June 2023 and 1 July 2023. The Credentials Committee elected H.E. Joachim Bleicker (Germany) as its Chairperson and Ms Jenny Louise Reid (New Zealand) as its Vice-Chairperson.
- 2. The Credentials Committee noted Rule III of the General Rules of the Organization on "Delegations and Credentials" as well as the practice and criteria followed by the Organization with respect to the acceptance of credentials, in accordance with the prevailing practice in the United Nations System, in line with United Nations General Assembly Resolution 396 (V). The Credentials Committee also noted that the Council, at its 148th Session held in December 2013, endorsed proposals to further streamline the overall process of acceptance of credentials, including through reliance on credentials issued by Permanent Representatives accredited to the Organization, taking into account the duration of sessions of the Conference, as well as the practice of other organizations of the United Nations System.
- 3. 188 Member Nations, one Member Organization, the European Union, and one Associate Member, Tokelau, have submitted credentials or information on the composition of their delegations. Six Member Nations and one Associate Member have not provided any information on their participation or representation in the Conference session.
- 4. The Committee noted that the Secretariat had received communications from two different delegations, each asserting that it represents the Government of Myanmar at the 43rd Session of the Conference.
- 5. The Credentials Committee, noting the decisions of the 77th Session of the United Nations General Assembly, the World Health Assembly of the World Health Organization (WHO) at its 76th session held from 21 to 23 May 2023 and the International Labour Conference of the International Labour Organization (ILO) at its 111th Session held from 1 to 16 June 2023, decided to recommend to the Conference that it defer a decision on the credentials of Myanmar, pending guidance from the United Nations General Assembly, on the understanding that no one would represent Myanmar at the 43rd Session of the Conference.
- 6. The Credentials Committee recommended to the Conference that the credentials of the delegations listed in the Annex to this Report be accepted and that those delegations be authorized to participate fully in the Conference Session. The list reflects the situation as of 1 July 2023.
