EXECUTIVE SUMMARY

The document presents the Status of Contributions to the Regular Programme as at 30 June 2023 showing receipts of current assessments and arrears presented as follows:

The main points highlighted are:

As at 30 June 2023:

1. Total number of Member Nations that had paid their 2023 contributions in full is 92.
2. One hundred and two (102) Member Nations still owed current assessments (in full or in part), totalling USD 136.2 million and EUR 101.4 million (Appendix A/Appendix B) related to year 2023.
3. The collection rate for current assessments (Year 2023) was 48.5 percent.
4. Sixty-three (63) Member Nations owed arrears (relating to assessments for 2022 and prior years) totalling USD 42.0 million and EUR 22.9 million (Appendix B/Appendix C) as at 30 June 2023 and which was equivalent to 14.4 percent of current assessments.
5. Eighteen (18) Member Nations had arrears in such amounts as to jeopardize their right to vote in accordance with Article III.4 of the Constitution (Appendix G).

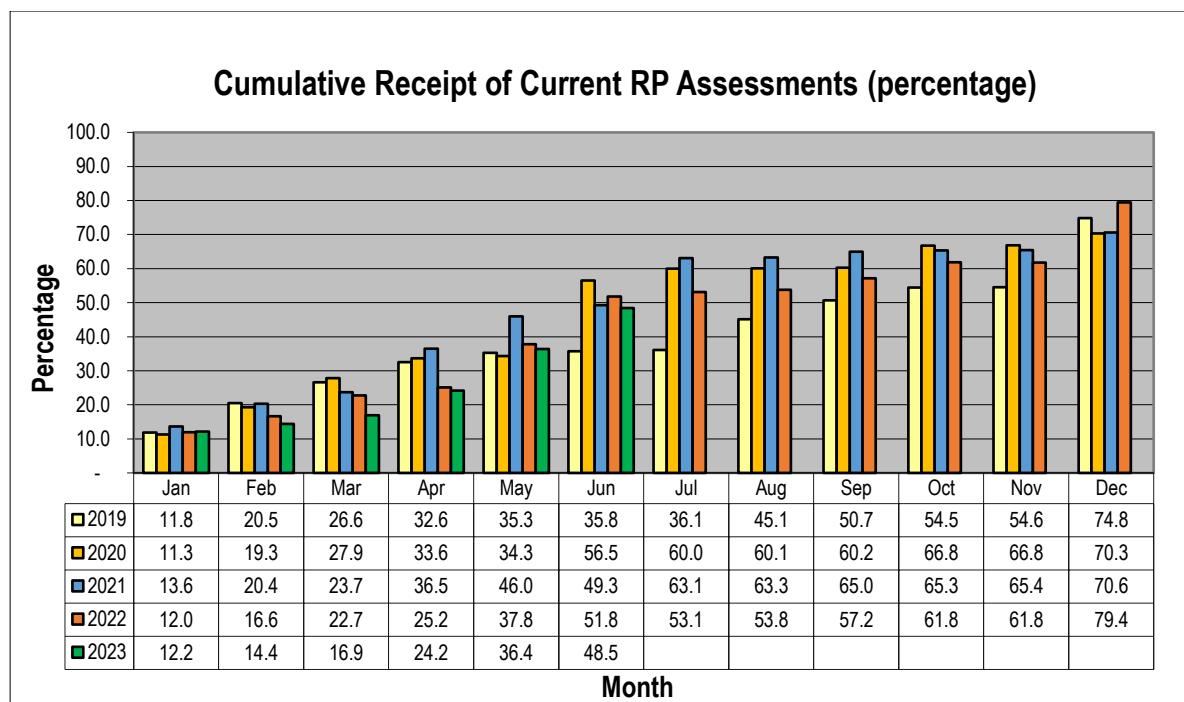

ADDITIONAL INFORMATION REGARDING ARREARS DUE AT 30 JUNE 2023

- The total arrears at 30 June 2023 was USD 42.0 million and EUR 22.9 million (*Appendix B/Appendix C*) equivalent to 14.4 percent of current assessments.
- Nine (9) Member Nations had arrears in excess of USD 1 million: Argentina, Cuba, Iran (Islamic Republic of), Iraq, Libya, Nigeria, Pakistan, United States of America and Venezuela (Bolivarian Republic of). In addition, USD 8.4 million remain outstanding from the former Socialist Federal Republic of Yugoslavia. In line with the established practice of FAO, the issue of the arrears accumulated by the former Socialist Federal Republic of Yugoslavia will be dealt with by taking into account the final decision (still pending) taken on the matter at the United Nations (*Appendix C*).
- Arrears exceeding USD 1 million accounted for 92.2 percent of the total arrears due.
- Eighteen (18) Member Nations had arrears in such amounts as to jeopardize their right to vote in accordance with Article III.4 of the Constitution (*Appendix G*).
- The total of sixty-three (63) Member Nations in arrears at 30 June 2023 was lower than the figure of sixty-eight (68) as at 30 June 2022.
