Appointment of the Chairperson and the Alternate Chairpersons of the Appeals Committee

Executive summary

Further to the revision of the appeal procedure set forth under FAO Manual Section 331, the Council is requested to appoint a Chairperson and two Alternate Chairpersons of the Appeals Committee.

Suggested action by the Council

The Council is invited to nominate H.E. Ms Daniela Rotondaro, Ambassador of the Republic of San Marino and Permanent Representative to FAO as Chairperson of the Appeals Committee, and H.E. Ms Haifa Aissami Madah, Ambassador of the Bolivarian Republic of Venezuela and Permanent Representative to FAO, and Mr Khalid Mehboob, Advisor/Alternate Permanent Representative of the Islamic Republic of Pakistan to Rome-based UN Agencies, as Alternate Chairpersons, for terms of two years effective immediately. These appointments are renewable twice.

I. Introduction

1. Staff Regulation 301.11.1 provides as follows:

"301.11.1 The Director-General shall establish a Committee within the Organization to advise him in cases of appeal by individual staff members regarding a grievance arising out of disciplinary action or arising out of an administrative decision which staff members allege to be in conflict, either in substance or in form, with the terms of their appointment or with any pertinent Staff Regulation, Staff Rule or administrative directive. (...) The Committee shall consist of two members and ten alternate members nominated by the Director-General, two members and ten alternate members elected by the staff as a whole, and an independent Chairperson appointed by the Council. The Council shall appoint two alternate Chairpersons to serve when the Chairperson is unavailable; if the Chairperson and alternate Chairpersons are unavailable, the remainder of the Committee may select an ad hoc Chairperson, who shall not be a staff member."

2. Currently, the Chairperson and Alternate Chairpersons of the Appeals Committee are as follows:

Chairperson: H.E. Ms Daniela Rotondaro, Ambassador of the Republic of San Marino and Permanent Representative to FAO (appointed by the Council at its 143rd Session for an indefinite term)

First Alternate Chairperson: H.E. Mr Mario Arvelo Caamaño, Ambassador of the Dominican Republic and Permanent Representative to FAO (appointed by the Council at its 149th Session for a term of three years)

Second Alternate Chairperson: H.E. Ms Jackline Lumumba Yonga, Ambassador of the Republic of Kenya and Permanent Representative to FAO (appointed by the Council at its 166th Session for a term of three years).

II. New Appeal Procedure

- 3. In January 2023, the Director-General approved a revision of the appeal procedure set forth under FAO Manual Section 331, which includes new provisions promulgated on 18 September 2023.
- 4. Among these new provisions, Staff Rule 303.1.34 and Manual paragraph 331.4.21 read as follows:
 - "303.1.34 <u>Composition</u>. The Appeals Committee shall be constituted as follows: a) a Chairperson and two alternate Chairpersons appointed by the Council; (...)"
 - "331.4.21 The Chairperson, alternate Chairpersons (...) hold office for two years and may be reappointed twice."

III. Proposed Appointments

- 5. In accordance with these new provisions, the Council is requested to appoint a Chairperson and two Alternate Chairpersons for terms of two years renewable twice. These appointments are to take effect immediately.
- 6. Further to consultations conducted by the Legal Office, the Council is invited to consider the appointment of the following candidates, who have confirmed their availability:

Chairperson: H.E. Ms Daniela Rotondaro, Ambassador of the Republic of San Marino and Permanent Representative to FAO

Alternate Chairperson: H.E. Ms Haifa Aissami Madah, Ambassador of the Bolivarian Republic of Venezuela and Permanent Representative to FAO

Alternate Chairperson: Mr Khalid Mehboob, Advisor/Alternate Permanent Representative of the Islamic Republic of Pakistan to Rome-based UN Agencies.
