FIRST REPORT OF THE CREDENTIALS COMMITTEE

1. The Credentials Committee held its first meeting on 6 November 1993 at 16:00 hours and its second meeting on 8 November at 09:00 hours to examine the credentials of the Delegations of Members to the Twenty-seventh Session of the FAO Conference. The Committee commenced its work by electing the Delegate of Cyprus, H.E. Ambassador F. Poulides as Chairman of the Committee.
2. In accordance with Rule III-2 of the General Rules of the Organization and the criteria established by previous committees, the Credentials Committee examined the Credentials of 165 Delegations and found them to be valid. The Members to which these Delegations belong are shown in the attached list (APPENDIX A).
3. To date four nations have not registered. They are:

Yugoslavia
4. Any other credentials which will be received, will be examined by the Committee at subsequent meetings.
