APPLICATION FOR MEMBERSHIP IN THE ORGANIZATION

1. Following document C 95/10 and in accordance with Rule XIX-2 of the General Rules of the Organization (GRO), Article II-2 of the Constitution and Rule XIX-1 GRO, the Director-General wishes to inform the Conference that he has received an additional application for membership of the Organization.
2. A letter from the Minister for Foreign Affairs of the Republic of Tajikistan was received in the form of a facsimile communication on 26 July 1995. A formal instrument of acceptance of the relevant obligations of the Constitution of FAO was submitted with the application (Appendix A). This application was communicated by Circular Letter G/CA 11/1 of 17 October 1995 to FAO Member Nations by the Director-General in pursuance of his responsibilities under Rule XIX-2 of the General Rules of the Organization.
